Reference: Resolution of Affirmation of Oath of Office and Support of US and Virginia Constitution

**Background**

As you all are aware there has been much discussion regarding the Second Amendment of the US Constitution and the right to bear arms. Attached is a resolution affirming the oath of office that each of you took when you became an elected official and specifically affirming the responsibility to respect, preserve, uphold, and enforce the Second Amendment.

**Needed Action**

**A RESOLUTION IN AFFIRMATION OF THE OATH OF OFFICE  
AND REGARDING A COMMITMENT TO RESPECT, PRESERVE, UPHOLD,  
AND ENFORCE THE SECOND AMENDMENT (US CONSTITUTION)  
AND ART. 1, § 13 (VA CONSTITUTION)**

**WHEREAS** the Code of Virginia (1950), as amended, § 15.2-1522 provides that every elected officer, unless otherwise provided by law, on or before the day on which their term of office begins, shall qualify by taking the oath prescribed by § 49-1;

**WHEREAS** the Code of Virginia (1950), as amended, § 49-1 prescribes the Oath of Office of the members of the Franklin City Council of Franklin, Virginia, as follows: I do solemnly swear that I will support the Constitution of the United States, and the Constitution of the Commonwealth of Virginia, and that I will faithfully and impartially discharge all the duties incumbent upon me as an elected member of the City Council according to the best of my ability, so help me God;

**WHEREAS** the Constitution of the United States at Amendment II expressly states that a well regulated Militia, being necessary to the security of a free State, the right of the people to keep and bear Arms, shall not be infringed;

**WHEREAS** the Constitution of Virginia at Article I, § 13 expressly states that a well regulated militia, composed of the body of the people, trained to arms, is the proper, natural, and safe defense of a free state, therefore the right of the people to keep and bear arms shall not be infringed;

**WHEREAS** there is concern that unconstitutional or unlawful legislation, which infringes upon the rights of the citizens to keep and bear arms under the Constitutions of the Commonwealth of Virginia (Article 1, § 13) and the United States (Amendment II), or which has the tendency to infringe upon or place any additional burdens on the right of law-abiding citizens to bear arms, may be introduced in the legislative sessions of the General Assembly of the Commonwealth of Virginia and/or the United States Congress; and,

**WHEREAS** there is concern that unconstitutional or unlawful executive and administrative action or enactments, which infringe upon the rights of the citizens under the Constitutions of the Commonwealth of Virginia (Article 1, § 13) and the United States (Amendment II), or which have the tendency to infringe upon or place any additional burdens on the right of law-abiding citizens to bear arms, are being considered by the Governor of the Commonwealth of Virginia and/or the offices and agencies under his control.

**NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE CITY COUNCIL OF FRANKLIN, VIRGINIA THAT:**

1. As a body collective, the Council hereby affirms the Oath of Office pursuant to the Code of Virginia (1950), as amended, § 49-1 committing to support the Constitution of the United States, and the Constitution of the Commonwealth of Virginia, and to faithfully and impartially discharge all the duties incumbent upon the Council to the best of its ability;
2. The City Council expresses its commitment by any and all legal means to Respect, Preserve, Uphold, and Enforce the Second of Amendment of the Constitution of the United States and Article 1, § 13 of the Constitution of the Commonwealth of Virginia to the fullest extent permitted by law;
3. Nothing herein this Resolution is intended to declare any intent or effectuate any act, present or prospective, by the Council or any City officer or employee in contravention of law, including but not limited to Va. Code Ann., §15.2-915.
4. The City Council implores the Virginia General Assembly, the United States Congress, and other agencies of the Commonwealth of Virginia and the United States Government vigilantly to preserve, uphold, and protect the rights of the citizens to keep and bear arms under the Constitutions of the Commonwealth of Virginia (Article 1, § 13) and the United States (Amendment II) by rejecting any provision, law, or regulation that may infringe, have the tendency to infringe, or place any additional burdens on the right of law-abiding citizens to bear arms;
5. The City Council expresses its commitment to oppose unconstitutional and unlawful legislation and proposed restrictions that infringe upon the right of its citizens to keep and bear arms, or which have the tendency to infringe upon or place any additional burdens on the right of law-abiding citizens to bear arms, through any and all legal means, as may be expedient, including without limitation, court action;
6. The City Council directs staff to forward a copy of this Resolution to the City's elected representatives in the Virginia General Assembly and the United States Congress, and to the Governor of Virginia; and,
7. The City Council hereby declares the City of Franklin, Virginia a "Constitutional City".

Re: Capital Replacement of Automated Side Loader Refuse Truck

The Department of Public Works is requesting approval to purchase a 2020 International Automated Side Loader refuse truck. The new truck will replace a 2007 model truck with 62,337 miles and 9,930 hours. The body and packer of the old truck was beyond repair and has been sold as surplus equipment. Originally this replacement was budgeted in FY 18-19 but was not purchased due to cash balances being below the recommended percentages. Below is the anticipated replacement schedule for the refuse truck fleet. If you have any questions or concerns, please let me know.

**Background**

Each year City Treasurer Dinah Babb provides you an update on delinquent real estate, personal property, meals, and lodging taxes. The only taxes being requested to authorize writing off is the meals tax.


**Needed Action**


Motion to write off the meals tax that has passed the statute of limitations on collection.



# City Treasurer 2019 Annual Report

Delinquent Taxes as of  
November 30, 2019





The delinquent tax amount for the City of Franklin as of November 30, 2019 is \$635,329.14. This amount reflects tax years 2017 and older for all taxes owed to the city. The last collection report dated November 30, 2018 was reported with delinquencies of \$344,163.82. This increase is primarily due to the real estate taxes.

## Real Estate

As of November 30, 2019 there is \$465,180.78 in delinquent Real Estate taxes for years 2001-2017. This increase is due to 3 properties that was backed taxed due to change of ownership. The property was previously tax exempt and now due to the change has become taxable. The amount of this delinquency is \$210,067.12. We currently have 18 taxpayers on monthly payment plans or have attached wage liens against their employment. The Treasurer's office continues to work with Jason A Dunn, PLC (Tax Attorney) out of VA Beach to assist in selling properties who meet the requirement for a tax sale based on the Code of Virginia 58.1-3965.1. There are currently 24 properties being worked by Mr. Dunn's Firm. We had a tax sale in Sep, 2019 where 5 properties were sold. The sale has been authorized by the court and \$20,740.43 will be disbursed to the office within a few weeks by Mr. Dunn's Firm.



## Real Estate Cont...

Mr. Dunn's firm will also work with property owners who are willing to enter into a payment agreement to keep property from being sold at a tax sale.

For RE2018 tax year, of the 5.5 million budgeted, we have \$259,798.00 uncollected, showing a 95% collection rate as of November 30, 2019. Any payments paid on delinquent real estate is applied to the oldest tax first.

## Personal Property

As of November 30, 2019 there is \$168,658.95 in delinquent personal property taxes for tax years 2008-2017. We continue to work with taxpayers on monthly payment plans. These plans are broken down to payments that will have the account paid off before the next billing cycle. If taxpayers pay their payment plan as agreed, they will have no additional collection action taken against them. If plans are broken without communication with the office, collection action will commence as allowed by State Code.

For PP2018 tax year, of the 2.8 million budgeted, we have 164,424.79 uncollected, showing a 94% collection rate as of November 30, 2019. Due to the tax conversion, we were unable to apply DMV Stops and vehicle seizures during the conversion, but anticipate the ability to do so in the next few months.

## Meals and Lodging

Currently there is \$1,452.66 in delinquent meals tax and \$00.00 lodging. The only account that is currently delinquent is from a business that is closed and the owner is deceased. The taxes were filed after the business closed by a family member without any payments making it impossible to collect.

Due to the status of this account, I'm requesting Council to approve the charging off of \$1,452.66 in delinquent meals tax based on the business is closed and the owner is deceased.

## Business License

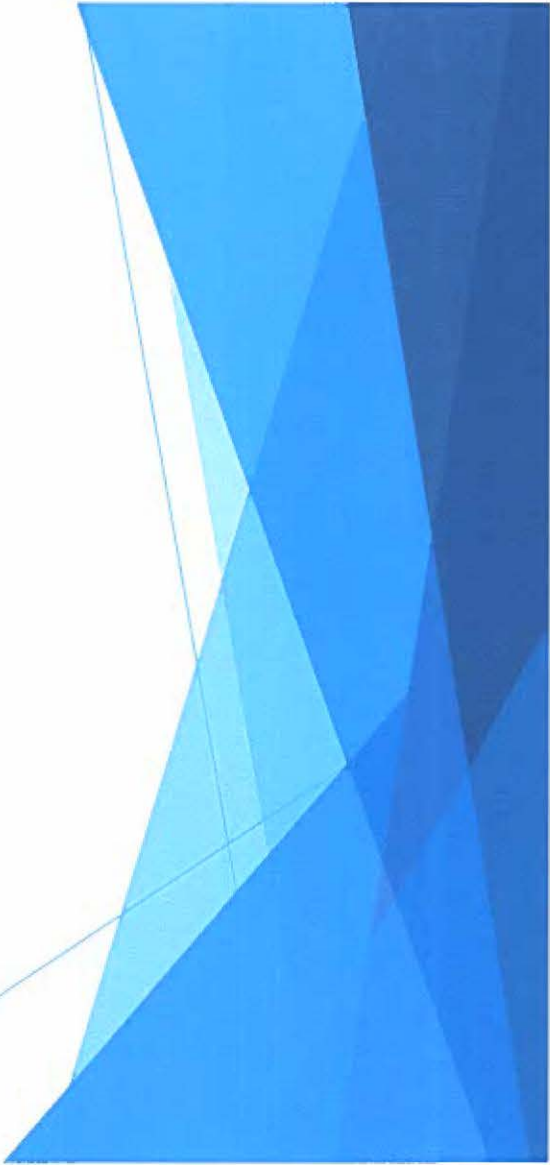
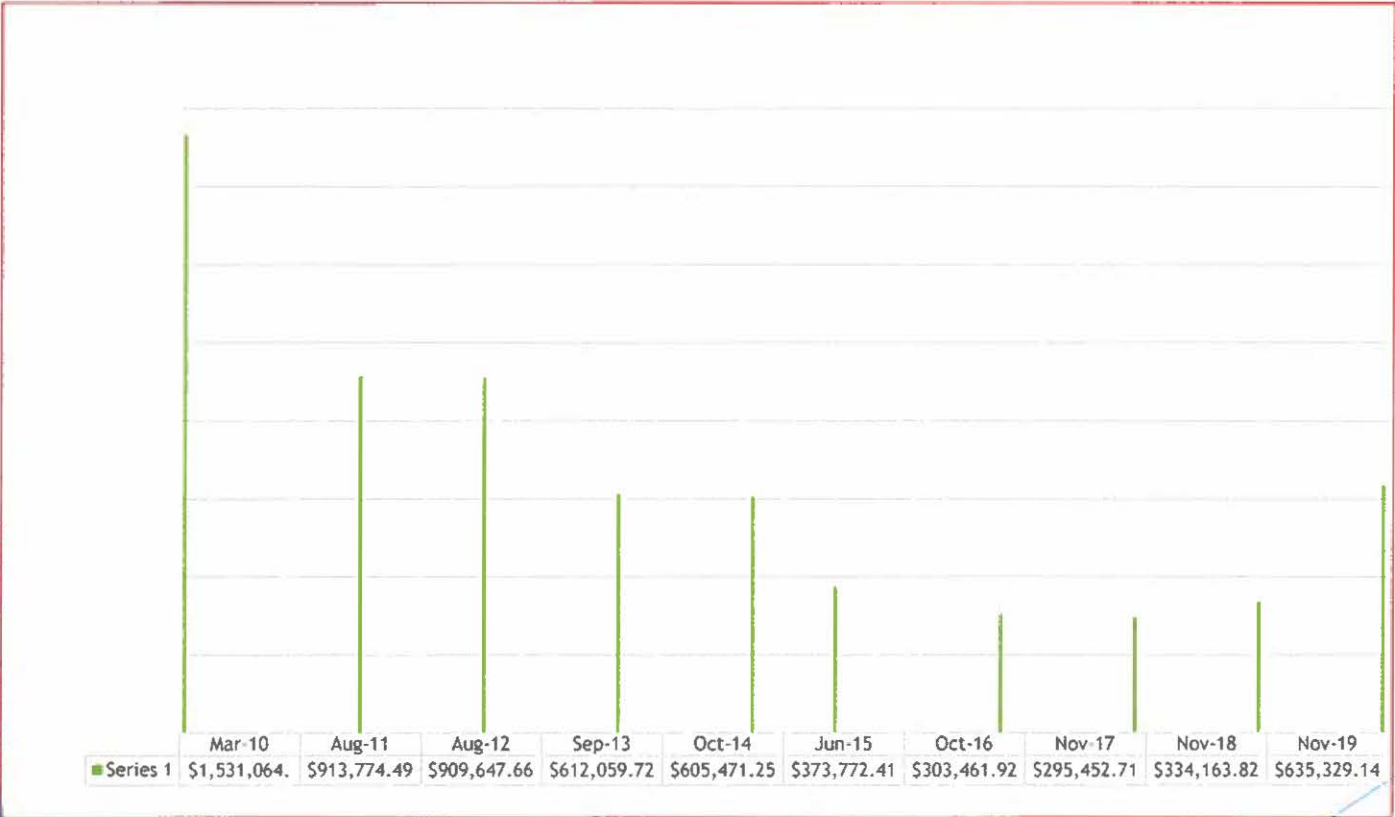

### **General Updates**

- As a result of the borrowing package and bond refinancing City staff went through
- The Verizon Tower project is estimated to be completed by the end of December 2019.
- We were informed by Bay Disposal that due to the instability in the recycling markets effective January 1, 2020 the rate per home to collect single stream recycling will increase from \$2.66 per home to \$3.48 per home. Our plan is to cover these expenses through vacancy savings with open positions if possible.
- Moody's affirmed the City's A1 rating and Moody's also gives us the benefit of Virginia State Intercept which means we continue with an "enhanced" Aa1 rating. S&P Global Ratings assigned its 'AA' rating, and stable outlook, to the City of Franklin, Va.'s series 2019 general obligation (GO) refunding bonds. At the same time, S&P Global Ratings affirmed its 'AA' rating, and stable outlook, on the City's GO debt outstanding.
- The Franklin Police Department has installed a medication disposal box in the lobby for citizens to dispose of unused or expired drugs.
- As a reminder solid waste operations will not occur on City holiday's. Trash pickup notifications are posted on the City's website as well as social media page.
