Financial Matters Budget Amendment #2022-12

City Manager Amanda Jarratt called Tracy Spence, Director of Finance to come forward and give the following overview of Budget Amendment #2022-12:

The 2020-2021 City Budget will be amended to:

- 1. Recognize additional Federal and State revenue in the amount of \$139,108.00 from the Department of Behavioral Health & Development Services and appropriate such revenue for new use:
- Reallocate unspent ARPA completed Governmental Services project funds in the amount of \$22,336.00 to a new ARPA Governmental Services project for COVID Public Health Mitigation expenses; and
- 3. Recognize the School's supplemental appropriation of State and local revenue in the amount of \$178,744.00 and to appropriate for new use.

Mayor Frank Rabil entertained a motion to approve Budget Amendment #2022-12.

Councilman Linwood Johnson made a motion to approve Budget Amendment #2022-12. The motion was seconded by Councilman Mark R. Kitchen.

Franklin City Public Schools Carryover Request

City Manager Amanda Jarratt stated at the December 2021 work session between City Council and the Franklin City Public School Board (FCPS), they indicated verbally and later in writing that they did not need the \$577,200.00 carryover. That being said the Budget Amendment was removed from a previous agenda. City Manager Jarratt stated she could not comment on where the confusion stemmed from however, after a meeting with the school system several weeks ago they are now saying the \$577,200.00 is needed.

City Manager Jarratt called Amy Phillips, Chairwoman for the Franklin City Public School forward to review the following Franklin City Public Schools Carryover Request:

Franklin City Public Schools (FCPS) has reviewed its financial spending plan through the life of the ESSER III Grant. They decided to resubmit the request for the \$577,200.00 unexpected fund balance as of June 30, 2021, to satisfy low cash flow balances due to large expenditures during the grant period. This will assist in the prevention of the negative cash flow that occurred in October 2021.

As discussed during the Friday, February 4, 2021 meeting, the \$577,200.00 would be placed in a restricted contingency line that would only be used for the float of grant expenditures. And if at any time FCPS would like to use any portion of the \$577,200.00, to cover a non-grant funded expense that would not be replaced, a request would need to be approved by both the FCPS School Board and City Council before expending.

Code of Virginia Title 22.1 Education Chapter 8. Public School Funds Article 1. State and Local Funds

22.1 – 100. Unexpected School and Educational Funds

All sums of money derived from the Commonwealth which are unexpended in any year in any school division shall revert to the fund of the Commonwealth from which derived unless the Board of Education directs otherwise. All sums derived from local funds unexpended in any year shall remain a part of the funds of the governing body appropriating the funds for use the next year, but no local funds shall be subject to redivision outside of the locality in which they were raised.

Code 1950, 822-138; 1956, Ex. Sess., c.67; 1980, c. 559.

City Manager Jarratt answered this has not been an issue in the past.

City Manager Jarratt stated City Council could restrict the \$577,200.00 and require that FCPS request the funds when needed.

*At six (6) months into the fiscal year, local tax revenue has exceeded targeted projections with the exception of cigarette taxes. If revenue collections continue at current pace, there will be a \$243k excess.

Revenue & Expenditure Summary – Cash Basis

General Fund revenue at the end of the period totaled \$15.7 million and represented 59% of budget which is \$1.9 million greater than the prior year. This is primarily attributable to the \$1.9 million in real estate sale proceeds from Global Concentrate.

General Fund expenditures at the end of the period totaled \$11.6 million and represented 42% of the total budget; when compared to the prior year period of \$10.5, this is a net \$173k decrease.

Airport Fund

Councilman Gregory McLemore asked how long has the Airport been showing a loss.

City Manager Amanda Jarratt answered every year.

Councilman Linwood Johnson confirmed that the airport had received some grant funds last year.

City Manager Jarratt answered yes the airport has received some grant funds in the past couple of years.

Water & Sewer Fund

Revenue Analysis

Revenue from the sale of water and sewer service charges of \$1.8 million at the end of the period is above target at 53.6% of budget and is \$115k greater than prior year period revenue.

Expense Analysis

Expense in the fund are \$784k and below target at 32.8% of budget and \$72k spent more when compared to prior year expenses.

*Note: This will have no effect on the Electric Fund's Unrestricted Net Position. At June 30, 2021, the Unrestricted Net Position was 23% of the Electric Fund's budgeted annual expenses. This is within the Council's approved policy limits of 15% to 25%.

Utility Bill Discussion

Councilman Gregory McLemore stated he wanted to let the City of Franklin's citizens know that there was two weeks of snow and with that comes higher utility bills. Councilman McLemore added that he had a citizen contact him and tell him that his normal utility bill averages \$250.00 a month. This past month his utility bill was \$1200.00.

Councilman McLemore thanked City Manager Amanda Jarratt for warning him however, this month he actually received a bill for \$7,591.00. He expressed concerns about other citizens receiving incorrect utility bills.

City Manager Jarratt replied that Councilman McLemore's utility bill was not a glitch in the billing system but, there was a problem with his meter. The meter needed to be replaced and the incorrect reading was entered.

City Manager Jarratt informed Council that the City of Franklin would be moving to an AMI system in the near future which means our meter readings will be completely automated.

Adoption of State of Emergency

City Manager Amanda Jarratt stated the Governor allows municipalities to declare a State of Emergency when bad weather or in case of any national disaster is expected. A State of Emergency allows the municipality to clear roads, restore power or act on mutual aid agreements.

Councilwoman Copeland moved to approve. The motion was seconded by Councilman Johnson. Further discussion was needed by Councilman Mclemore. No vote was taken.

City Manager's Report

City Manager Amanda Jarratt gave the following updates:

General Updates

- The City of Franklin staff continues to work with local, regional, and state partners to battle the impacts of COVID-19 and provide testing and vaccinations throughout the City. The City is currently seeing a large spike in cases locally and encourages individuals to remain vigilant.
- The City of Franklin Pay Study is underway. Portions of it will be incorporated into the FY-23 budget.
- The joint RFP with Southampton County regarding the radio system and tower needs has been issued. The City anticipates receiving responses in March.

Community Events

- The Franklin Garden Club and Spring Fest is scheduled for April 23, 2022.
- The Lumberjack Festival is scheduled for May 7, 2022.

DECLARATION OF A LOCAL EMERGENCY ON JANUARY 20, 2022 BY THE CITY OF FRANKLIN, VIRGINIA DIRECTOR OF EMERGENCY SERVICES

Whereas, The Director of Emergency Services of the City of Franklin, Virginia does hereby find as follows:

- 1. That due to occurrence of an impending winter storm the City of Franklin is facing a condition of extreme peril to the lives, safety, and property of the residents of the City of Franklin;
- 2. The City of Franklin is expecting to receive between 4 6 inches of snow and sustained temperatures below 32 degrees over the next twenty-four hours.
- **3.** That as a result of this extreme peril, the proclamation of the existence of an emergency is necessary to permit the full powers of government to deal effectively with this condition of peril.

Now, Therefore, be it proclaimed and ordered that during the existence of this emergency the powers, functions, and duties of the Director of Emergency Management and the Emergency Services organization and functions of the City of Franklin shall be those prescribed by the laws of the Commonwealth of Virginia and the ordinances, resolutions, and approved plans;

In order to carry out the effect of this resolution, the City Manager Amanda C. Jarratt or the Director of Finance, Tracy Spence and their designees, are hereby authorized to expend funds form the City's unappropriated fund balance to cover the reasonable operations costs of emergency services pending further report to Franklin City Council and such additional appropriations as shall be deemed necessary to cover the expected scope of this emergency and ratified by City Council.

Now, Therefore; I Amanda C. Jarratt, Director of Emergency Services, for the City of Franklin Virginia do hereby proclaim and declare that a local emergency exists in the City of Franklin, Virginia, effective on the 20th day of January 2022.
