Regular City Council Meeting Minutes July 11, 2022

Call to order

The Franklin City Council held a regular City Council meeting on July 11, 2022 at 7:00 P.M. in the City Council Chambers located at 207 West Second Avenue, Franklin, Virginia 23851.

Council Members in Attendance: Frank Rabil, Mayor; Robert "Bobby" Cutchins, Vice-Mayor; Councilman Linwood Johnson; Councilwoman Wynndolyn Copeland; Councilman Mark Kitchen; Councilman Gregory McLemore.

Citizen's Time

Mayor Frank Rabil asked Council if there any corrections or amendments that need to be made to the June 27, 2022 regular City Council minutes.

Mayor Frank Rabil affirmed the motion carried unanimously.

B. National Parks and Recreation Month Resolution will be deferred to the next City Council meeting on July 25, 2022 when Parks and Recreation staff will attend.

Old/New Business:

A. Langston Court Lot Sale Public Hearing

Mayor Frank Rabil asked City Manager Amanda Jarratt to provide information before moving to the public hearing.

City Manager Amanda Jarratt stated as some may recall the City of Franklin implemented a Community Development Block Grant in the area of Langston Court in the early 2000s, the partnership was between the City of Franklin and the Franklin Redevelopment Housing Authority and another private partner, which is no longer involved. There is a program income plan which requires that the sale of any remaining lots in the development, the proceeds be split equally, between the City of Franklin and Franklin Redevelopment Housing Authority. It was the intent that the lots that remain be deeded in the name of Franklin Redevelopment Housing Authority. However, the Franklin Redevelopment Housing Authority now has a buyer for those lots, and when the title search was done, it was discovered that it was incorrectly deeded in the name of the City of Franklin. Unfortunately, despite weeks of research to see if there was a way around that, there was not. When the City of Franklin sales public property, the City if required to have a public hearing. The public hearing along with the resolution, will allow the City of Franklin to execute any necessary documents to complete the closing. It is important to conduct the public hearing and adopt the resolution which allows the City to execute those documents in order to move to closing as soon as possible.

Councilman Linwood Johnson stated that there are members of the Franklin Redevelopment Housing Authority present and would like them to explain what they are doing and how this will enhance the Housing Authority.

Councilman Gregory McLemore stated that he would like to know the date in which the Langston Court sale was discussed. City Manager Amanda Jarratt stated that Franklin Redevelopment Housing Authority owns the lots, thought they were owned, which they should. The Franklin Redevelopment Housing Authority marketed the sale, which they are allowed to do, at this time there is a buyer. When the title search was done, it was made clear the title was in the wrong name. Once the Franklin Redevelopment Housing Authority sales these lots, they will give half of the proceeds to the City of Franklin and they keep the remaining half. City Manager Amanda Jarratt stated that during a closed sessions several months ago, under real estate, it was advised to Council of the mistake and the need to conduct the public hearing. Advertisement must be done before the public hearing, which must run twice before the public hearing.

Mayor Frank Rabil stated that the members of the Franklin Redevelopment Housing Authority can speak now during this discussion or during the public hearing.

Ms. Gwendolyn Blue, Executive Director Franklin Redevelopment Housing Authority, stated that unsolicited purchase request from FMW in March regarding the Langston Court lots. The Franklin Redevelopment Housing Authority asks Council to please approve this resolution so that the Franklin Redevelopment Housing Authority may move forward with the sale of the lots and complete the transaction.

Mayor Frank Rabil asked is any other representatives from the Franklin Redevelopment Housing Authority would like to speak before opening the public hearing.

Mayor Frank Rabil opened the public hearing for the Langston Court lot sale.

No speakers at this time. Mayor Frank Rabil closed the public hearing for the Langston Court lot sale. The floor was given to City Council for discussion.

Councilman Linwood Johnson stated that Langston Court is in his ward, and would like to do what is best for the neighborhood and feels that this will enhance the neighborhood by getting other houses in the area.

Councilman Linwood Johnson made a motion to adopt the resolution to approve sale and conveyance of real property Langston Court lots #2022-18 with a second from Councilwoman Wynndolyn Copeland.

Councilman Gregory McLemore stated that Langston Street extends from South Street back into a culde-sac, how many more houses this will add to that cul-de-sac. City Manager Amanda Jarratt stated that there are houses and townhouses on the back left hand side of the cul-de-sac, their intent is to construct single family dwellings. There will be six (6) additional single family dwellings.

B. Redistricting Ordinance 2022-01

City Manager Amanda Jarratt stated as the Council recalls, Map C was adopted for the redistricting process. The next step is to adopt that ordinance that will codifies Map C, so this becomes a section in the City code. This outlines what the Council adopted in Map C. Once this is adopted, Council will

submit the entire package to the Office of the Attorney General for their approval. This being one of the final steps towards the adoption of what Council has already done.

City Attorney Christopher Mackenzie stated what is being done, is Chapter 7.5 of the City code addresses this now, but speaks to the old map. This will update Chapter 7.5 of City code to track with the new map.

Councilwoman Wynndolyn Copeland asked if Ashton included in ward 5, City Manager Amanda Jarratt stated what is shown the driving directions.

Councilman Gregory McLemore asked when a map by colors will be done accurately, now there are map of one of the wards showing with two colors. City Manager Amanda Jarratt stated that the final map will be given once it is completely done. This the final piece in finishing this, the Attorney General offices approves it, then we can say this is the final map c.

Councilman Gregory McLemore asked when the list of the registered voters in the new wards, City Manager Amanda Jarratt stated that this must be completed first, Ms. Jennifer Maynard, Registrar, can't do any of that until this is approved by the Attorney General office.

Ms. Jennifer Maynard, Registrar stated that the cards that were sent out were for the state wide redistricting, not local.

Mayor Frank Rabil asked if there were any other questions by Council. The public hearing for redistricting was opened.

No one spoke at this time. Mayor Frank Rabil closed the public hearing.

Councilman Gregory McLemore made a motion to adopt the Redistricting Ordinance #2022-01 with a second from Vice Mayor Bobby Cutchins.

Mayor Frank Rabil affirmed the motion carried.

City Manager Amanda Jarratt stated the packet will now be submitted, once there is final approval from the state, then the maps will be reissued for the Council to have.

C. Armory Discussion

City Manager Amanda Jarratt stated as the Council knows, moving forward with several capital projects in the City of Franklin and two major ones are the Armory and the City of Franklin Courthouse. The Council needs to make a decision, which does not have to be this evening. Staff is in the process of needing to start to procure architects and contractors for both of those projects. There needs to be a decision of which direction to go in regards to the Armory. Council has been provided reports in regards to the current state of the Armory. The current reports gives the analysis of the asbestos, lead, and all mechanical system associated with the building, including its structural capacity. Shown in the report is the shell of the building and the bad foundation. Staff is hesitant to take an existing building that we know has a tremendous number of issues and try to make it work. When we know, if we were to demolish the facility and build back new, we can have absolutely what we need to better serve the community and not to rush or fit what we know we need into an existing shell of a building.

City Manager Amanda Jarratt stated that things that are most concerning to the staff is the structural foundation of the building, because as outlined, it is clear that the building has shifted over time and these are just things that were visible observed at the facility. Whenever a renovation is done, there is always something that you didn't anticipate finding. The architectural estimate to rehab the existing facility range from a low of \$4 million to a high of \$6 million, that being at the beginning of COVID, 25-30% can be added now. Staff feels that if the building was to be demolished, it would save the City a tremendous amount of money, by demolishing what is there and build back the site precisely what is needed. The City needs a gym, the current gym facility in the Armory does not currently have bleachers, and the size of the office space and the locker rooms aren't what you would want for today's requirements.

City Manager Amanda Jarratt stated that a decision does not have to be done during the meeting, however, in the process of working with Davenport borrowing money, this would more than likely reduce that \$12 million number, if the City would demolish and rebuild. The City is also working with Congressman Scott office for \$2 million in support of this project. Per Ms. Paige in Congressman Scott office, there is no known timeframe on when that funding will be granted. It was originally included on the House side, but will eventually need to be included on the Senate, in theory it will be done in September when they adopt the federal budget. However, last year there were several continuing resolutions and things weren't approved until March. Councilman Linwood Johnson stated in thinking about this, the cost for demolishing the facility, could the staff get us an estimate. City Manager Amanda Jarratt stated based on recent projects that have been built in the area, we could demolish and rebuild for cheaper than you would, trying to retrofit the facility.

City Manager Amanda Jarratt stated that staff will clearly go with what Council decides, however, staff recommendation is to demolish and rebuild. Making it the central hub of the City of Franklin's Park and Recreation operations, have offices there, allow opportunities for the college to use, discussion of the Food Bank utilizing it. The staff sees it as a space to have a gym, locker rooms, the opportunity to play volleyball, and meets the requirements of today's standards.

Councilman Gregory McLemore asked how much has been spent for the study so far and how much was the grant for. City Manager Amanda Jarratt stated this is a grant and there are no City funds, the grant awarded \$30,000 to Camp Community College. The City wrote letters of support because the City owns the facility, but the applicant and the grantee was Camp Community College. Councilman Gregory McLemore asked if the City were to either demolish or reconstruct the facility, is there a time line would be before the City could take possession of such facility. City Manager Amanda Jarratt stated probably 18-24 months based on current supply chain and demand, and the City also have to move forward with the financing. City Manager Amanda Jarratt stated that if the City stays on track with Davenport, the City could have a gym facility in 2024, which is the plan that is outline in the plan of finance. Mayor Frank Rabil stated that based on the information provided, it is more than likely best to demolish and rebuild rather than renovate the building. Councilman Gregory McLemore stated the only concern is demolition is permanent and would hate to demolish the facility without a guarantee that the City will replace it. For example High Ground Services now resides in a building that was empty and left for disrepair for a few decades, and it was able to be renovated. City Manager Amanda Jarratt stated that the money and funding has already been approved.

Councilman Gregory McLemore wanted to be sure that the facility will remain in control of the City opposed to the college, where the City would need to get permission to use. City Manager Amanda Jarratt stated that the consensus that was heard, is to move forward down the path of demolish to start a design of a new facility. Staff will start down that path of the new design and will come before the Council. The interim financing includes the funding to pay the architect to do the plans. Councilman Gregory McLemore asked is there a way as the City moves forward with construction projects, that the City can create a caveat that we are able to give some of these jobs to local business. Councilman McLemore stated that he knows there is not much control over who is chosen to complete the construction projects.

City Manager Amanda Jarratt stated that when new companies coming into the community Mr. Heck and his team meet with them, and they try to reach out the Chamber for local business that available for individuals to use. Secondly, when the City has companies that have to performance agreements, there is language that is included in there that the City strongly encourages them to utilize local business and to hire citizens of the local community. Not sure legally if that can mandated, but it is strongly encouraged.

No action taken at this time.

D. Southampton County Courthouse Update

City Manager Amanda Jarratt stated the following:

- Preparatory work for the Dominion Energy transformer relocation is now complete and their construction crew is expected to be onsite to relocate the transformers and primary cable in the next couple of weeks.
- Interior framing is nearing completion in the 1960's building along with the electrical and plumbing rough in work.
- The estimated completion date is now July of 2023.
- Change Order Number 4 was authorized this month in the total amount of \$111,855.10 which will be covered by the project contingency. The majority of the cost is associated with a recommendation from the structural engineer to address unforeseen irregularities in the masonry façade of the 1960's building which were not visible to anyone until the precast stone panels were removed from the building exterior. The engineer's recommendations were to completion remove the irregular masonry and replace it with a 14 gauge cold from steel framing.
- The total construction contract, including change orders 1-4 now stands at \$21,762,713.21.
- E. City Manager's Report

Mayor Frank Rabil wanted to discuss what happened on Lee's Mill Road. City Manager Amanda Jarratt stated lighting struck a tree in an area of the Lee's Mill Road where the City of Franklin line goes through. The fire was not put out which lead to one of the power poles causing it to catch on fire. The

reason for the extensive delay in having the power restored, was there was no way for the power trucks to get to the pole, due to someone digging a significant ditch. City Manager Amanda Jarratt thanked Mr. Chad Edwards, Director of Public Works and his staff for coming off of what they were working on to assist Franklin Power & Light. The Public Works department had to build a 75 foot long 12 foot wide road, then put a 12 inch diameter pipe to create a culvert for the Power and Light trucks to actually access the power line. The crews were cutting down trees to get them out of the way and wait for the fire to be extinguished. The AMI meters that are being installed will give the City the ability to be able to communicate with the citizens, now that technology is not available. Once the conversion is done, the City will be able to communicate with the citizens. Normally, the City does not have power outages to this degree unless it is absolutely significate like on Bailey Drive. The Public Works department also had a water main break on Clay Street while working with Power & Light on the outage. Mr. Zachary Wright, Director of Power & Light updated that the power was back on around 6:30 P.M.

City Manager Amanda Jarratt stated that the RFP has been issued for architectural services for the Franklin Courthouse, it is being reversed engineered. The estimated completion date for the County Courthouse is July 2023. The City has received the certificate of achievement for excellence financial reporting, much thanks to the Finance staff and Department Heads that worked to make our audit such that we could receive this award again.

Background Information

As you may recall when funds are received in excess of one percent of the City of Franklin's operating budget a new budget public hearing must be held. As a result of various influxes of grant funding and federal funding the FY 23 budget is being increased as outlined in budget amendment 2023-1. A public hearing is required.

Needed Action

Conduct the public hearing regarding the additional funds coming into FY 23 budget. At the conclusion of the public hearing consider Budget Amendment 2023-1.
