- Wyndoll Hilliard - Doris Artis moved that the name Wyndoll Hilliard be invalid as a write in candidate. Purlie Banks seconded it.
- Charlie Ashburr - Doris Artis moved that the name Charlie Ashburr be invalid as a write in candidate. Purlie Banks seconded it. Motion passed.
- Charlie Asbb - Doris Artis moved that the name Charlie Asbb Be invalid as a write in candidate. Purlie Banks seconded it. Motion passed.
- Charles Ashburn - Doris moved that the name Charles Ashburn Be invalid as a write in candidate. Purlie Banks seconded it. Motion passed.

NOTE: For a name to be a valid write in, the person had to reside in Ward 3, be a registered voter and the general registrar had to be able to confirm their registration. Charlie Ashburn had 33 votes; Charlie Ashburn, Jr. had 48 votes; Vincent E. Davis had 1 vote; Richard A. Walker had 1 vote; Richard Walker had 2 votes and 16 votes were invalid.

The Electoral Board certified the election and abstracts.
