FINANCIAL

Budget Amendments General Fund FY 2013-14

Manager Martin reviewed the Budget Amendments General Fund FY 2013-14 which is a request from Ellen Couch, Executive Director of Smart Beginnings, to appropriate the FY 2013-2014 budget in the total amount of \$285,700. This amount does not include any prior year carryover funds; these funds will be amended at a later date upon reconciliation and/or audit of financial reports.

A motion was made by Councilman Burgess to amend the FY 2013-2014 Budget to include the budget as approved for Smart Beginnings (Fund 204) and appropriate the funds for expenditure. The motion was seconded by Vice-Mayor Cheatham and passed with a 6-0 vote (Councilman Blythe absent).

OLD/NEW BUSINESS

Consider an Amendment to the Personnel Policy Section 101 2 (b) – Part Time Employees

City Attorney Williams reviewed the current Full-Time/Part-Time Employment Policy which states a full-time Employment status requires a minimum of $37^{1/2}$ hours per week, or 1950 hours per year. The current Part-Time Employment Policy states part-time employment status shall be deemed to exist whenever a position is assigned fewer hours per pay period than a comparable full-time position. Unless expressly authorized, part-time employees are not eligible for benefit programs other than legally mandated benefits such as worker's compensation insurance, Social Security, legal holidays and Family Medical Leave in certain circumstances. However, part-time employees are subject to Work Rules and Policies as set forth in Sections 601 through 609, Employee standards of conduct as set forth in Sections 701 through 710 and disciplinary grievance procedures as set forth in Sections 801 through 802.

City Attorney Williams recommended some amendments to the policy describing Part-Time Employment which will state Part-Time Employment status shall be deemed to exist whenever a position is scheduled to work an average of less than 30 hours per week. Unless expressly authorized, part-time employees are not eligible for benefit programs other than legally mandated benefits such as worker's compensation insurance, Social Security, legal holidays and Family Medical Leave in certain circumstances. However, part-time employees are subject to Work Rules and Policies as set forth in Sections 601 through 609, employee standards or conduct as set forth in Sections 701 through 710 and disciplinary grievance procedures as set forth in Sections 801 through 802.

Councilman Burgess asked if the City's Policy states full-time is a minimum of $37^{1/2}$ hours per week and part-time is less than 30 hours per week; what if an employee works 34 hours a week.

City Attorney Williams answered this would have to be managed by the Department Head.

City Attorney Williams informed Mayor and Council that due to a recent change the Affordable Health Care Act will not take effect as previously scheduled until January 2015. It was originally scheduled to be effective January, 2014.

City Attorney Williams stated that another thing to consider is the benefit package that would be available for any employees in the gap between full-time and part-time.

Councilwoman Murphy stated she felt this policy needed to be researched further before a decision is made.

Councilman McLemore is in agreement with Councilwoman Murphy that this policy needs to be researched further before action is taken by Council.

Manager Martin announced there is a Webinar scheduled for next week that he and Carolyn Joyner, Director of Human Resources will be participating in that will hopefully clarify the recent delay in effective date of certain provisions of the law and answer policy questions.

Mayor Johnson-Ashburn and Council were in agreement that this Policy should be brought back to Council for further discussion in the future after further research.

City Manager's Report

Manager Martin did not have anything additional to report at this time.

COUNCIL/STAFF REPORTS ON BOARDS AND COMMISSIONS

Mayor Johnson-Ashburn thanked Vice-Mayor Cheatham for standing in for her while she was away.

Mayor Johnson-Ashburn advised that she had attended a ribbon cutting for the new pool at the Girl Scout Camp at Camp Darden.

Mayor Johnson-Ashburn also advised that she, Councilman Burgess, Councilwomen Hilliard and Murphy attended a luncheon for Congressman J. Randy Forbes held on Friday, June 21, 2013 at the Country Club given by the Franklin-Southampton Area Chamber of Commerce and The Franklin Rotary Club.

Mayor Johnson-Ashburn also stated it was a pleasure to participate with Councilwomen Hilliard and Murphy in the first Kick-Ball kick-off event recently sponsored by the Parks & Recreation Department.

Vice-Mayor Cheatham informed Council about the Joint Shared Services Committee Meeting that was held with Southampton County officials and stated at the moment everyone is in the discussion stage regarding sewer.

Vice-Mayor Cheatham also reported on June 30, 2013, that he and Councilwoman Murphy and her son attended Unity Day at the White Oaks Springs Baptist Church, representing the City.

Vice-Mayor Cheatham informed Council that he spoke at the Patriotic Music Presentation held at the Armory and sponsored by the Downtown Franklin Association (DFA) which he stated was a very nice event.

Enclosed is a proposed Resolution authorizing staff to continue to work toward a decision on what action to take for the City regarding disposal of our municipal solid waste after January 24, 2018. The Resolution contemplates looking at continued participation in the SPSA organization post 2018 by meeting with the other SPSA communities to work on a mutually acceptable Use and Support Agreement for post 2018. It is not a recommendation for a commitment to SPSA. It is just a recommendation that the City continue to examine SPSA as an option available to the City. The Board of Supervisors of Southampton County and Isle of Wight County will be reviewing similar resolutions at their respective July Board meetings.

A NON-BINDING RESOLUTION OF THE FRANKLIN CITY COUNCIL CONCERNING SOLID WASTE COLLECTION AND DISPOSAL AFTER JANUARY 24, 2018

Whereas, the City of Franklin, Virginia (the "City") is a member of the Southeastern Public Service Authority ("SPSA") which was created by concurrent resolution of the Cities of Chesapeake, Franklin, Norfolk, Portsmouth, Suffolk and Virginia Beach and the Counties of Isle of Wight and Southampton (the "Localities") in 1976; and,

Whereas, between 1983 and 1984, the City and the other Localities entered into individual Use and Support Agreements with SPSA, providing, among other things, that each member jurisdiction would deliver substantially all of the disposable solid waste generated or collected by or within or under the control of the Localities to SPSA; and,

Whereas, all of the Use and Support Agreements will expire on January 24, 2018; and,

Whereas, over the course of SPSA 's existence significant debt was incurred that resulted in severe financial hardship requiring the increase of tipping fees to unprecedented levels beginning in early 2009; and,

Whereas, in an effort to resolve its financial issues, SPSA refinanced its bond obligations and sold assets to reduce debt with the goal of eliminating all SPSA debt by the date of expiration of the current use and Support Agreements; and,

Whereas, in anticipation of the expiration of the Use and Support Agreements, the Chief Administrative Officers of the member Localities of SPSA directed a technical committee to be established in order to review and address numerous policy and operational issues (the "Committee"); and,

Whereas, the City supports the on-going work of the Committee and is also currently considering a number of alternatives to provide municipal solid waste collection and disposal services to citizens of the City in a cost effective manner and in compliance with all applicable laws and regulations governing the same (the "Alternatives"); now, therefore,

BE IT RESOLVED BY THE FRANKLIN CITY COUNCIL that the City Council recognizes the continued participation as a member of SPSA on terms and conditions acceptable to the City and in the best interests of City residents should be one of the Alternatives to be examined by the City, and the City Manager and other City staff are directed to participate in the Committee and Committee negotiations with the goal of evaluating such continued participation in SPSA as an Alternative, taking into account all issues they consider to be in the best interests of the City.

Memorandum of Agreement Between The Hampton Roads Transportation Planning Organization And The City of Franklin, Virginia

This Memorandum of Agreement is executed as of ______, 2013, by and among the Hampton Roads Transportation Planning Organization ("HRTPO"), and the City of Franklin, Virginia ("Franklin").

WHEREAS, Chapter 766, 2013 Virginia Acts of Assembly, effective July 1, 2013, codifies the enactment of HB2313, establishing new revenues for transportation projects ("HB 2313 Revenues"), a portion of which will be deposited to a newly established Hampton Roads Transportation Fund (the "Fund") to be expended for projects in the Planning District 23; and

WHEREAS, HB2313 imposes certain new and increased taxes in those cities, counties and towns comprising Virginia Planning District 23 that will be deposited into the Fund, and requires that monies in the Fund be used for transportation projects in all localities of that Planning District 23; and

WHEREAS, the HRTPO is the designated MPO for the Hampton Roads Metropolitan Planning Area, which does not include the City of Franklin, nor Southampton County (hereinafter collectively referred to as "the Localities" and individually as "Locality"); and

WHEREAS, the HRTPO is designated by HB2313 to identify those transportation projects for which monies in the Fund may be expended; and

WHEREAS, the Localities are not members of the HRTPO, and therefore this Agreement does not provide the Localities with any authority to participate as a voting member in the federal planning processes conducted by the HRTPO in its capacity as an MPO, which processes include, but are not limited to, development of the Transportation Improvement Program and Constrained Long-Range Transportation Plan for the Hampton Roads Metropolitan Planning Area; and

WHEREAS, the parties hereto desire to establish a mechanism by which the Localities will be entitled to vote on the allocation of funds for projects supported by HB2313 revenues deposited into the Fund.

NOW, THEREFORE, the parties hereby agree as follows:

- 1. Effective July 1, 2013, the HRTPO shall establish "Fund set-asides" for each of the Localities by maintaining information, received from the various state agencies responsible for collecting and depositing HB2313 Revenues into the Fund, relating to the portions of the HB2313 Revenues attributable to the imposition/collection of HB2313 taxes in each of the Localities and deposited into the Fund, and shall reserve sums equivalent to said portions of the HB2313 Revenues, which sums shall be expended for projects located in each Locality, outside the boundaries of the Hampton Roads Metropolitan Planning Area.
- 2. Effective July 1, 2013, each of the Localities shall be entitled to one vote on actions of the HRTPO involving the allocation of funds for any project to be funded in whole or in part with HB2313 Revenues in the Fund set-asides for the Localities in Paragraph 1 above.
- 3. Each of the Localities shall appoint one individual to represent it, and, subject to the provisions of Paragraphs 1 and 2 above, exercise the right of the Locality to vote, on the allocation of HB2313 funds before the HRTPO. The representative shall be an elected official appointed by the governing body of the Locality. Each of the Localities shall designate an alternate authorized to act in the absence of the appointed representative of the Locality, who shall also be an elected official.
- 4. The representatives of the Localities shall be invited to attend all meetings of the HRTPO in which any allocation of HB2313 Funds are to be discussed or otherwise considered and shall be provided with all information and communications relating to said allocations that are provided to HRTPO members, and for those meetings in which allocations of funds for projects meeting the conditions set forth in Paragraphs 1 and 2 above are to be discussed or will be subjected to a vote, shall be provided with all information and communications relating to said projects that are provided to the HRTPO members, and shall be allowed to participate in discussions relating to said projects.
- 5. This Agreement may be amended or revoked only by further written instrument executed by all parties hereto. This Agreement shall remain in effect until such time as it is revoked by the parties hereto.
