Minutes from the September 9, 2013 Regular City Council Meeting

The Franklin City Council held a Regular City Council Meeting on Monday, September 9, 2013, at 7:00 p.m. in the Council Chambers, 207 West Second Avenue.

Council Members in Attendance: Raystine D. Johnson-Ashburn, Mayor; Barry Cheatham, Vice-Mayor; Greg McLemore, Benny Burgess, Mary Hilliard, and Mona Murphy (Councilman Don Blythe absent).

Staff in Attendance: Randy Martin, City Manager; Taylor Williams, City Attorney; Russ Pace, Director of Public Works; Dan Howe, Director of Downtown Franklin Association; Mark Bly, Director of Power & Light; Alan Hogge, Director of Social Services; Carolyn Joyner, Director of Human Resources; Vince Holt, Chief of Emergency Services; Dinah Babb, Treasurer and Phil Hardison, Chief of Police.

CALL TO ORDER

The Regular City Council Meeting was called to order by Vice-Mayor Cheatham which opened the meeting for Mayor Johnson-Ashburn at 7:00 p.m.

INVOCATION

The invocation was offered by Vice-Mayor Cheatham.

PLEDGE OF ALLEGIANCE

The Pledge of Allegiance was recited by everyone in attendance.

Mayor Johnson-Ashburn thanked Vice-Mayor Cheatham for opening the meeting.

CITIZEN'S TIME

Citizen 1

Thomas Councill resides at 425 Bracey Street stated his concerns about the City of Franklin's Parks and Recreation Department being an underperforming department. He stated it is underperforming because of City Council's negligence. He also criticized the Department's new youth program development. In his opinion, Council should direct the City Manager in regards to the Parks and Recreation Department. Mr. Councill requests City Council hold a public hearing on the Department of Parks and Recreation with the main topic being new youth programs. He also suggested a bike program possibly using the surplus bicycles slated for disposal.

AMENDMENTS TO AGENDA

Vice-Mayor Cheatham motioned to amend the Agenda to include in the Closed Session a discussion with the City Attorney on the disposition of publicly held real property where the discussion in an open meeting would adversely affect the bargaining position or negotiating strategy of the public body pursuant to Virginia Code Section 2.2-3711 (A)(3). The motion was seconded by Councilman Burgess and passed with a 6-0 vote (Councilman Blythe absent).

CONSENT AGENDA

Minutes from August 26, 2013 Regular City Council Meeting

Mayor Johnson-Ashburn asked if there were any corrections to the Minutes from August 26, 2013 Regular City Council Meeting.

Councilman Burgess stated there was one correction on page 1, 9th paragraph; sentence should be corrected to read:

Mayor Johnson-Ashburn welcomed Mr. Artis on behalf of herself and Council; instead of Mayor Johnson-Ashburn welcomed Mr. Artis on the behalf of herself and Council.

Mayor Johnson-Ashburn asked for adoption of the Minutes from the August 26, 2013 Regular City Council Meeting with the correction.

A motion was made by Councilman Burgess to approve the minutes of the August 26, 2013 regular City Council Meeting with the correction made. The motion was seconded by Vice-Mayor Cheatham and passed with a 6-0 vote (Councilman Blythe absent).

OLD/NEW BUSINESS

City Manager's Report

Sale of Surplus Property (Bicycles)

City Manager Martin informed Council that the City of Franklin Police Department has collected abandoned bicycles from various people and places over a period of time that are being stored at the Police Department. These bicycles have remained unclaimed. The Police Department provided Council with a listing of 107 bicycles for which no owner can be identified. The Police Department is requesting these bicycles be declared surplus property by the City Manager so they can be sold at Public Auction pursuant to City Code Section 23.5-32 (A). See Below:

Section 23.5-32. Sale of surplus property.

(a) The City Manager shall have the authority to dispose of as scrap any items of surplus, obsolete or worn out personal property not suitable for sale if the cost of storage and sale exceeds the value of such items. The City Manager shall have the authority to order a sale at public auction any items of surplus, obsolete or worn out personal property suitable for sale if the cost of storage and sale is not expected to exceed the value of such items. Sales at public auction shall be held after at least ten day calendar days notice in a newspaper of general circulation in the city and such other notice as is deemed advisable.

There is no action required by City Council unless there is an objection to the bicycles being declared surplus by the City Manager and authorized for sale at public auction. The sale will be advertised in the Tidewater News at least once ten days before the date of the sale.

Manager Martin asked if there were any questions.

Councilman McLemore asked where these bicycles originated from.

Manager Martin answered these bicycles were either stolen or abandoned on public property. Manager Martin asked Chief Hardison to give further details about the bicycles.

Chief Hardison confirmed Manager Martin's answer.

Councilman McLemore asked if the bicycles could possibly be used as rewards to children that are doing well in school.

Chief Hardison answered some of these bicycles are in disrepair and all have been left out in the weather for several years.

Mayor Johnson-Ashburn asked what the next step would be for disposing of these bicycles.

Manager Martin answered if Council has no objection the next step would be disposal of the bicycles by the procedure authorized.

Councilman McLemore asked where the funds would go after these bicycles are auctioned or disposed of.

Manager Martin responded the funds would go into the General Fund account for future appropriation by Council.

Holiday Pickup Schedule

Manager Martin stated there were some citizen concerns expressed about the Holiday Refuse Pickup Schedule. He presented and reviewed the Holiday Refuse Pickup Schedule. In an effort to better inform the public, the Manager wanted to report on the schedule to the Council. The basic change from past practices was to avoid no collection on most holidays which required doubling up collections on subsequent collection days. The schedule through the end of the calendar year is as follows:

Manager Martin stated this schedule will be posted in the Tidewater News, PEG Channel, and all Departments.

Councilwoman Hilliard asked if the City would need to adjust the policy.

Manager Martin answered the policy would be reviewed to see if any change was needed.

Councilwoman Murphy suggested this be added to a future goal session if a policy change was necessary.

Councilman Burgess asked how this schedule change would affect our employees.

Manager Martin recognized Russ Pace, Director of Public Works to explain in further detail.

Mr. Pace answered this is done on a voluntary basis in which the crew would start their day at their normal time. They are normally done early but are paid for an eight hour day plus they get time and a half for the hours they actually work.

Councilwoman Hilliard asked does the recycle collection contractor operate on the same Holiday Schedule.

Mr. Pace answered yes they do.

Councilwoman Hilliard asked if everyone had been cross trained to run these routes.

Mr. Pace confirmed this.

Manager Martin stated once this schedule is put in place he believes citizens should prefer it.

Councilwoman Hilliard asked why the City has such a hard time finding people to fill vacant Sanitation positions.

Mr. Pace answered he believes it is because of the salary.

Mayor Johnson-Ashburn stated Council will be addressing City wide salaries and compensation in future goal and budget sessions.

Councilwoman Hilliard requested the PEG channel be kept updated.

Councilwoman Murphy also requests an update on the new IT equipment purchases.

Public Meetings

Manager Martin reminded Council of the Public Meetings concerning the City/County Waste Water Study scheduled for 6:00 p.m. Wednesday, September 11, 2013 in Franklin and 7:30 p.m. Thursday, September 12, 2013 in Courtland.

Mayor Johnson-Ashburn recognized and welcomed Cain Madden, the new Managing Editor for the Tidewater News.

COUNCIL/STAFF REPORTS ON BOARDS AND COMMISSIONS

Councilman Burgess provided an annual report for 2011 & 2012 hand-out reviewing compiled data from the City's Business Incubator. The Incubator now has 128 full time employees and 154 part time employees, average salary is \$43,644. The taxes paid to Franklin and to the State of Virginia generated \$9,800,000 in revenue. The Franklin Incubator was recognized in the Rural Incubator Magazine.

Councilman Burgess also reported on the Franklin's Present Committee Meeting. The Committee has asked for some data from the programs that are offered to the students from Pre-K through Third Grade and the committee should have this information by the next meeting.

Mayor Johnson-Ashburn thanked everyone on the Franklin's Present Committee and School Board for all their time spent which is personal time because this is a volunteer effort.

Councilwoman Hilliard reminded Council that the Franklin's Present Committee is not Council appointed.

Vice-Mayor Cheatham reported on recent meetings of the Tidewater Regional Jail to discuss the Federal Prisoner situation. The Authority has agreed to table any decision until after local officials visit Washington on Wednesday, September 11, 2013 for a meeting with Congressional Representatives and Federal Marshal Service Representatives.

CLOSED SESSION

A motion was made by Vice-Mayor Cheatham to meet in closed session to have a discussion with the City Attorney on the disposition of publicly held real property where the discussion in an open meeting would adversely affect the bargaining position or negotiating strategy of the City, and consult with the City Attorney pertaining to actual civil litigation where such consultation in open meeting would adversely affect the negotiating or litigation posture of the City pursuant to Virginia Code Section 2.2-3711 (A) (3) and (7). The motion was seconded by Councilman McLemore and passed with a 6-0 vote.

The motion was seconded by Vice-Mayor Cheatham and passed with a 6-0 vote (Councilman Blythe absent).

CALL TO ORDER

The Regular City Council Meeting was called to order by Mayor Johnson-Ashburn at 6:30 p.m.

AMENDMENTS TO AGENDA

A motion was made by Councilman McLemore to add to the Agenda the consideration of a Hunterdale Ruritan Club Anniversary Recognition Resolution. The motion was seconded by Councilman Burgess and passed with a 6-0 vote (Councilman Blythe absent).

A motion was made by Vice-Mayor Cheatham to add to the Agenda a Closed Session discussion of the acquisition of easements pursuant to the Virginia Code Section 2.2-3711 (A) (3) where a discussion in an open meeting would adversely affect the bargaining position or negotiating strategy of Council. The motion was seconded by Councilman Burgess and passed with a 6-0 vote (Councilman Blythe absent).

A motion was made by Councilman Burgess to add to the Agenda consideration and discussion of the performance of the Franklin City School Board in Closed Session pursuant to the Virginia Code Section 2.2-3711 (A) (1). The motion was seconded by Vice-Mayor Cheatham.

After considerable discussion on the motion with each member of the Council commenting, the motion to amend the Agenda to add this topic failed to receive a majority vote of approval.

The motion failed with the votes as follows:

A motion was made by Councilwoman Hilliard to add to the Agenda consideration and discussion of scheduling a Regular Meeting of the City Council for October 7, 2013 at 7:00 p.m. at City Hall since the second Monday, October 14th is a holiday. The motion was seconded by Councilman Burgess and passed with a 6-0 vote (Councilman Blythe absent).

A motion was made by Councilwoman Hilliard to add to the Agenda consideration and discussion of scheduling a special Joint Called Meeting of the City Council and the Franklin School Board for Wednesday, October 23, 2013 at 6:30 p.m. at a site to be determined. The motion was seconded by Councilwoman Murphy and passed with a 6-0 vote (Councilman Blythe absent).

Mayor Johnson-Ashburn advised the approved amendments would be added to the Agenda after the scheduled Closed Session.

There being no further adjustments suggested by members of Council, Mayor Johnson-Ashburn asked for a motion to go into Closed Session as scheduled on the Agenda.

CLOSED SESSION #1

A motion was made by Councilwoman Murphy to meet in closed session to discuss and consider appointments to boards and commissions, and to discuss prospective businesses or industries where no previous announcements have been made and consider investment of public funds where bargaining is involved and the financial interest of the City would be adversely affected if made public pursuant to Virginia Code Section 2.2-3711 (A) (1), (5) & (6). The motion was seconded by Councilman McLemore and passed with a 6-0 vote (Councilman Blythe absent).

The Council went into Closed Session at 6:58 p.m.

Motion Upon Returning to Open Session: Councilwoman Murphy moved that the only matters discussed during the session were those lawfully exempted from open meeting requirements and identified in the motion by which the Closed Session was convened. The motion was seconded by Vice-Mayor Cheatham and passed with a 6-0 vote (Councilman Blythe absent).

Mayor Johnson-Ashburn reconvened Open Session at 7:48 p.m.

Councilman McLemore left the meeting at 8:15 p.m.

Action 1

Mayor Johnson-Ashburn recognized Councilman Burgess who read aloud the proposed Resolution recognizing the 65th Anniversary of the Hunterdale Ruritan Club. A motion was made by Vice-Mayor Cheatham to approve the Hunterdale Ruritan Club 65th Anniversary Resolution. The motion was seconded by Councilman Burgess and passed with a 5-0 vote (Councilman McLemore and Blythe absent).

**COLLECTION REPORT FROM TREASURER
AS OF SEPTEMBER 30, 2013**

The delinquent tax amount for the City of Franklin is \$612,059.72. This reflects tax years 2012 and older. The last report from the treasurer was on August 06, 2012. The total amount delinquent on that date was \$909,647.66 showing a reduced amount in delinquent taxes of \$297,587.94. Since last reporting we have billed 2012 Tax Year.

REAL ESTATE:

Currently there is \$373,729.28 in delinquent real estate taxes. Of that amount \$195,385.15 remains delinquent for tax year 2012. We currently have 70+ taxpayers on monthly payment plans and wage liens. I continue to work with Jones, Jones & Dunn, PLC (Tax Attorney) out of Chesapeake VA to assist in selling properties who meet the requirement for a Tax Sale. Any property delinquent 2010 and older (not on a current payment plan) have been sent to the company. There are 47 properties currently being worked by Mr. Dunn. Taxpayers who are willing to enter into a payment plan with Mr. Dunn will be able to do so, but will have to have all taxes and any fees paid within 2 years, along with keeping current taxes paid. Should the taxpayer agree to the payment agreement their property will be pulled from the sale. Should they fail to meet the requirements; the property will be added back to the sale list.

PERSONAL PROPERTY:

Currently there is \$205,019.60 in delinquent personal property taxes. Of that amount \$57,977.18 remains delinquent from the 2012 tax year. We currently have 100+ taxpayers on payment plans. We continue to use various collection tools to assist the office in our collection efforts.

BUSINESS LICENSE:

Currently there is \$6,807.65 in delinquent business licenses. Any business that owes personal property taxes on their business, monies being paid will be applied to personal property before being applied to the business license. Currently there are no businesses that are in business that are delinquent for FY2012 and FY2013. We continue to research various sights looking for businesses that have closed and left owing the city money.

MEAL AND LODGING TAX:

Currently there is \$26,503.19 in delinquent meals tax and \$0.00 in lodging. There are currently only 3 businesses that have delinquent meals tax and only 1 business that remain open. Those businesses that have delinquent meals tax are on a payment plan with the office. The businesses are making payments towards the delinquent tax but must file and pay all current tax due. There are currently no businesses delinquent for FY2013.

Additional Information:

DMV-STOP- Since last reporting we have had 105 delinquent taxpayers satisfied with the DMV-STOP program. This program is only used as a collection tool for delinquent personal property taxes and parking tickets. Once a Stop is placed on the taxpayer it prevents the taxpayer from renewing their licenses and registration of vehicle.

DEBT SET OFF- Since last reporting we have had 666 claims and a total of \$118,885.80 applied to delinquent taxes and inactive utility accounts. This program is through the Virginia State withholding.

All taxpayers who have delinquencies with the City of Franklin are placed in this program. Should a taxpayer receive a Tax refund or Lottery winnings, those funds are captured and sent to the City.

VIRGINIA AUCTION COMPANY- Since September 2012 we have had 94 vehicle seizures with a total of \$22,738.68 collected in delinquent taxes. Of the 94 seizures there have been 3 not redeemed and sold at auction.

TAX SALE- We have had 2 successful Tax Sales with Jones, Jones & Dunn. The first was on Jan 24, 2013 and the second was on May 23, 2013. Eight properties were sold. These properties have delinquencies dating back as far as 2002. Properties were sold for enough to pay delinquent taxes, penalties, interest and nuisance liens associated with properties, attorney's fees and auctioneer fees. Only one property had to have late fees on the nuisance fees waived. We are scheduled for another Tax Sale on Nov 14th 2013 in council chambers. We should have at least 6 properties up for auction at that sale.
