B. Introduction of New Employees

City Manager Amanda Jarratt asked Sarah Rexrode, Director of Social Services to come forward to introduce her new employees. Mrs. Rexrode introduced Lashawna Ross, Supervisor of Family Services who has 18 years of social work experience. Mrs. Rexrode explained that Ms. Ross has been with the Franklin Department of Social Services since October 19, 2023.

Mrs Rexrode also introduced Tanisha Wyche, Human Services Assistant III. Ms. Wyche does hope to pursue her career in social work and would like to do so in the City of Franklin.

C. Recognition of STAR Performers

City Manager Amanda Jarratt stated that the STAR Performer nominations are coming in and that the following nominations will be last two that will be considered for Employee of the Year this calendar year. City Manager Amanda Jarratt reminded Council that the individuals that are nominated for STAR Performer will be entered into the Employee of the Year award to be selected by a committee of their peers.

Mr. Steve Watson, Deputy Director of Public Works recognized his employee Mr. Christopher Perry, Landscape Maintenance Technician. Mr. Watson stated that Mr. Perry makes Franklin City Hall look immaculate every day as well as maintains landscaping at 27 other properties owed by the City of Franklin. Mr. Perry takes the same pride and ethic in his work no matter the location. He has all the qualities of an exemplary employee. His attendance, punctuality, work ethic, attention to detail, motivation, positive attitude, and willingness to help others is second to none. Mr. Watson explained that Mr. Perry is an invaluable member of the Public Works team and can always be counted on to give one hundred percent each and every day.

Mrs. Rexrode, Director of Social Services recognized her employee Ms. LaToya Evans, Family Services Specialist II. Mrs. Rexrode explained that at the time of Ms. LaToya's hire as a Family Services Specialist I, social services were experiencing staffing shortages. Due to the volume of reports of child abuse and neglect, Ms. Evans was asked to conduct duties outside the scope of her position. Ms. Evans jumped right in, without complaint. She helped motivate her team with her humor, wit, and willing ness to help others. Ms. Evans displayed calmness and put her job first when working, and brings a level of professionalism to the agency. Ms. Evans is a member of the agency's Activities Committee. Ms. Evans continues to be a reliable employee, and at one point was the only full-time Family Services Specialist. She handled this enormous responsibility with grace and professionalism. Ms. Evans consistently process that she is willing to go above and beyond the scope of her duties.

Arbor Day Proclamation Resolution 2023-28

Old/New Business:

A. Old Dominion University Mobile Medical Unit Update

City Manager Amanda Jarratt stated that the ribbon cutting several months ago for the ODU Medical Bus that provides services to citizen within the City of Franklin, due to the impact a representative is here to provide an update to the community. City Manager Amanda Jarratt introduced Ms. Tammy Speerhas, from ODU to share information.

Ms. Speerhas stated that a year ago she sat with City Manager Amanda Jarratt and discussed the idea of coming into the community with a Mobile Unit to provide free care to the community. She stated that City Manager said a "Big Yes." Ms. Tammy stated that thanks to City Manager Amanda Jarratt, she was an interval part of ODU forming many partnerships. Over the past six months, ODU has had a ribbon cutting ceremony, and have been providing care in the City of Franklin community. ODU has established multiple sites including all of the schools, Martin Luther King Center, Farmer's Market, Armory Field, and has now branched to Courtland, Boykins, and Southampton County Schools as well.

Ms. Speerhas stated that they didn't expect the amount of pediatric care that was needed. When the ODU Bus came into the City, they were open to what the community needed, and since that time they have seen over 500 children in about six months providing sports physicals, back to school physicals, as well as their partnership with the Franklin Health Department allowing citizens to get free vaccines as well. She emphasized that the ODU Bus carries all free health care services. Ms. Speerhas stated that they have cared for over 100 adults, providing and managing chronic care, urgent care.

Ms. Speerhas stated that they are excited with new partnerships coming forward next year. ODU has partnered with Sentara Mobile Mammogram Unit and will now dedicate one day a month to women's

health. They are also building a mental health program for the upcoming years. Mayor Bobby Cutchins and City Council thanked Ms. Speerhas for what they are doing for our community.

B. Franklin City Public Schools Grant Application

City Manager Amanda Jarratt stated that in addition to the Literary Loan program the Commonwealth of Virginia has opened a grant program that school systems are eligible to apply for. Dr. Clint Walters, Director of Operations for the City of Franklin Public Schools walked City Council through a PowerPoint explaining the program. City Manager Amanda Jarratt added that at the end of the presentation there is a Resolution that if City Council chose to adopt would be added to this grant package.

Dr. Walters stated that the Virginia Department of Education is soliciting requests from local school divisions for grant funding of construction and renovation projects. The funding will range from 10 % to 30% of the total project cost. Based on the FCPS composite index, they are projected to receive 30% of the total cost The projects must fit into one of three categories, new construction, addition project or minor renovation.

- FCPS has prepared a SCAP application to fund major renovation of the HVAC infrastructure at S. P. Morton Elementary School, which is being phased over a two-year period.
- This application is requesting funding to cover a portion of Phase I.

Dr. Walters is requesting City Council to adopt a resolution affirming the language to maintain funding dedicated to public education for the duration of the project outlined in the SCAP grant. Councilman Gregory McLemore wanted clarification on the equipment that they would like to add to the classrooms. Dr. Walters explained that the control panels will allow FCPS Maintenance team access to monitor how efficiently the HVAC units are running. City Manager Amanda Jarratt stated that the application timing does not align with the audit, therefore we must get the application in this week.

RESOLUTION OF CITY COUNCIL OF THE CITY OF FRANKLIN, VIRGINIA, APPROVING APPLICATION FOR A GRANT FROM THE SCHOOL CONSTRUCTION ASSISTANCE FUND

RESOLUTION #2023-29

WHEREAS, the City Council of the City of Franklin, Virginia has determined that there is an urgent need to make capital improvements to the City's school facilities, specifically upgrades to the HVAC system at S.P. Morton and similar renovations at various school facilities for school purposes; and

WHEREAS, at a meeting of the City Council held in the City, the City of Franklin School Board has provided to the City Council an application addressed to the Virginia Board of Education through its Department of Education for the purpose of obtaining a grant from the School Construction Assistance Fund of \$189,094.35 for the Project.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FRANKLIN, VIRGINIA that that the Application of the School Board for a School Construction Assistance Fund Grant for the Project in the amount of \$189,094.35 is hereby approved and the City Manager and other City representatives are hereby authorized to take all actions to assist in completing and submitting such Application to the VDOE and authority is hereby granted to the School Board to apply for \$189,094.35 for the Project for the purposes set out in the Application.

FURTHER RESOLVED, that this Resolution shall take effect immediately.

D. Juneteenth Cultural Celebration 2024

City Manager Amanda Jarratt stated that Councilman Gregory McLemore provided City Council with the 2023 Juneteenth update and will present the 2024 Juneteenth presentation.

Councilman Gregory McLemore stated that the goal is for this to be a national tourism destination and revenue stream. Councilman Gregory McLemore stated that the City agreed to a five year plan. Amun Ra, Inc. (501c3) requested \$30,000.00 in grant funding and the City provided \$15,000 total with \$5,000.00 being grant funds, and \$10,000.00 being City funds. To recap the 2023 Juneteenth Cultural Celebration, it was held over a three day period, at five locations which held multiple events with security being provided by the Black Panther Party and the City of Franklin Police Department.

Councilman Gregory McLemore stated that free attractions, and creating the best Juneteenth Celebration in the nation will draw more people to the City of Franklin. Councilman Gregory McLemore suggested several ways to scale back and improve the Juneteenth event is the amount of event days, locations, attractions, and investments.

Councilman Gregory McLemore requested the same \$30,000.00 to fund next year's event. Councilman Gregory McLemore requested Councilwoman Jessica Banks to serve on the Juneteenth planning committee. Councilman Gregory McLemore stated that the goal is to make this year's event better than last years to ensure that we create a tourism event.

Vice-Mayor Wynndolyn Copeland asked the City Attorney if the City is it legal to give funds to Councilman Gregory McLemore and the 501c3. Councilman Gregory McLemore stated that he himself does not receive any of the funds and that grant funds were given directly to Amun Ra, Inc. Vice-Mayor Wynndolyn Copeland asked Councilman Gregory McLemore who serves on the Amun Ra, Inc. board. Councilman Gregory McLemore stated that any funds that were given to Amun Ra, Inc. were spent on the event itself. The Heather Lockerman, City Attorney responded that as a locality the City is permitted to give funds to a non-profit charity according to code section 15.2953. Therefore, the City could not give the funds directly to a Council member, however, the City is permitted to give funds to a non-profit organization. Councilman Ray Smith asked Heather Lockerman, City Attorney if a 501c3 can have paid employees. Heather Lockerman, City Attorney responded that it could.

Councilman Gregory McLemore stated that Juneteenth is an opportunity to bring visitors to the City. Mayor Robert Cutchins thanked Councilman Gregory McLemore for the report on the Juneteenth Cultural Celebration. Councilman Mark Kitchen asked if there was a way to combine the Juneteenth Cultural Celebration and Independence Day Celebration fireworks display. Heather Lockerman, City Attorney stated legally there would not be a problem with combining the events. City Manager Amanda

Jarratt stated that historically, the fireworks for the Independence Day Celebration have been paid for by sponsorship to the City of Franklin. Councilman Mark Kitchen asked if a portion of money be given to Amun Ra, Inc. and a portion of money be given to the Parks and Recreation Department would be financially and logistically impossible. City Manager Amanda Jarratt stated that it would be difficult. City Council agreed that the Juneteenth Cultural Celebration should be a City event that is handled by the Department of Tourism and Department of Parks and Recreation.

Mayor Robert Cutchins asked for any desired action from City Council. Councilman Gregory McLemore mad a motion to move forward with the Juneteenth Cultural Celebration with a second from Councilwoman Jessica Banks.

Mayor Robert Cutchins asked for any further discussion. Councilman Ray Smith stated that if one organization receives funding from the City in the amount of \$30,000.00, then all organizations who host events in the City should receive the same funding.

After discussion with Council, Councilman Gregory McLemore withdrew the motion.

Vice-Mayor Wynndolyn Copeland made a motion to appoint City staff to plan the 2024 Juneteenth Cultural Celebration with a second from Councilwoman Jessica Banks. Councilman Linwood Johnson amended the motion to have the Department of Parks and Recreation plan the event. Councilwoman Jessica Banks added the Department of Tourism should plan the event.

E. City Manager's Report

City Manager Amanda Jarratt reminded citizens of the ongoing Kia theft and recommended a secondary security for Kia vehicle owners, such as a steering wheel lock. City Manager Amanda Jarratt notified Council of the resignation from Jerry McCreary, Franklin City School Board. City Manager Amanda Jarratt stated we will need to schedule a public hearing in January. City Manager Amanda Jarratt reminded citizens of the Angel Tree, and informed individuals that they can pick up an angel from our Department of Social Services.

General Updates

- Staff continues to work on the various capital projects approved by City Council.
 - o Kimley Horne has been hired to navigate the HUD Grant process as mentioned in the previous City Council meeting. Our preliminary HUD package has been submitted to HUD and has been referred to final review. We are in the final stages of procuring the architect and should be able to start construction documents in the first quarter of 2024.
 - The staff committee for the courthouse renovation project will consist of Chief Steve Patterson, Chad Edwards, and Lin Darden. The judges, Clerk of Court, and Sherriff's Department in addition to other stakeholders will be consulted throughout the design process. A meeting was held with the architects and judges. Final changes to the plans are being made and we are now beginning to work on a more concrete timeline.
 - The staff committee met regarding Riverwalk Park.
 - The kayak design is underway. Survey is complete for the kayak launch additional area. We will incorporate this into the site plans.
 - Kayak launch design underway.
 - Flood study (no-rise study) underway. Not all bridge crossings requested from City are available. Awaiting completion of kayak launch to update.
 - At the moment we're currently awaiting the final site plan and kayak launch design before we can move forward with the Joint Permit Application for the VMRC and Corps permits. Once we have the final design in hand, we can prepare the required impacts mapping and update details relating to the VMRC component of the application. It should take us around 2 weeks to finalize the application after the plans are received.
- Staff continues to work with DHCD and Kimley Horn on the Laurel Street CDBG Grant. Client intake and income verifications have begun and contracts are about to be issued. There may be a funding shortage so the Management Team is investigating other sources of funds potentially including HOME Funds.
- Staff continues to meet with regional partners to discuss next steps on the regional radio system as well as violence and crime prevention.
- Three responses were received for the Franklin Southampton radio project and they are currently under review by the review team. Interviews of those firms are being scheduled for the first week in January.
- Staff continues to work with Court Services and our other locality partners for both short and
 long term solutions to the juvenile detention situation. An RFP to procure an architect to design
 a potential expansion of Western Tidewater Regional Jail. Mosley Architects has been selected
 to assist the Western Tidewater Jail Board to conduct the necessary feasibility study. A kick off
 meeting with Mosely was held on November 20th.
- The Literary Loan process continues with Franklin City Public Schools. The contactor is working on the project and the first draw of funds is underway. A second application was considered earlier on the agenda.
- City Council held a retreat on March 2nd. The following topics were discussed and will be worked on by staff:
 - Food Trucks
 - Two food trucks have received final approval.
 - Increased Code Enforcement
 - Staff is working on a demolition plan for the posted unsafe structures. We are putting a plan in place to prepare for high grass season. We are working with legal to draft updated ordinances for parking and vehicles.
 - Communication with Franklin City Public Schools
 - We held a joint meeting with Franklin City Public Schools on March 30th.
 Additional meetings are being scheduled to maintain communication.

- o Increased focus and investment in Public Safety
 - Additional positions are included in the FY 24 budget. The updated radio system project is moving to Phase 2.
- Historic District
 - Staff is reviewing the ordinance that is in place and providing a list of the individuals that need to be appointed. Staff is waiting on appointments from Franklin City Council.
- Youth
 - Working on updated youth programming and additional partnerships.
 - The College Drive park build was a success and is now open to the public. A
 variety of upcoming activities for youth are planned for the remainder of the
 summer.
- Special Tax Districts
 - Under discussion and research ongoing.
- Camp Community College Partnerships
 - Under discussion.
- o Improved Communication with the Public through various means
 - A review of the PEG Channel and necessary equipment purchases are underway.
 Staff is working to update City Clips. Staff is researching other best practices. An Instagram page has been created.

City Treasurer's 2023 Annual Report

Delinquent Taxes as of

November 30, 2023

▶ The delinquent tax amount for the City of Franklin as of November 30, 2023 is \$513,377.49. This amount reflects tax years 2021 and older for all taxes owed to the city. The last collection report dated November 30, 2022 was reported with delinquencies of \$427,135.84. This is an increase of \$86,241.65. This increase is due to adding the delinquencies for tax year 2021 as well as the effects from the higher tax assessments for 2022 personal property.

Real Estate:

- As of November 30, 2023 there is \$131,248.61 in delinquent Real Estate taxes for the years 2003-2021. The delinquencies consist of 62 residential, 3 multi-family, 13 commercial and 1 tax exempt for a total of 80 properties. The cumulative collection rate for these tax years is 99.86%. The office continues to work with citizens who have become delinquent with payment plans prior to collection actions. We currently have 10 tax payers on monthly payment plans. The office uses VEC (Virginia Employment Commission) for employment information and attach a lien against their place of employment based on the Code of Virginia 58.1-3919, Currently the office has about 12 on wage liens.
- The Treasurer's office continues to work with Jason A. Dunn, PLC (Tax Attorney) out of Virginia Beach to assist in selling properties who meet the requirements for a tax sale based on the Code of Virginia, 58.1-3965. There are currently 30 properties being worked by Mr. Dunn's firm. Prior to sending the file to the firm, the office has exhausted all possible efforts with the taxpayer.

Real Estate Cont....

- Prior to properties being put up for a tax sale, Mr. Dunn's firm will enter into a payment plan with the taxpayer. Once they enter into a plan the taxpayer must stay current on the plan and pay all current taxes by the due date.
- We had 2 tax sales this year. One in May where we sold one property by an online auction. The second sale was in October where we had 6 properties to be sold. Prior to the sale 5 of the properties were paid in full and pulled from the sale. The property remaining was sold through a hybrid tax sale. Both properties were sold for enough money to pay all delinquent taxes, nuisance liens as well as the attorney fees and auctioneer's fees. Having the sale as a hybrid tax sale gives a wider foot print of people bidding on the sale that other wise might not be able to make the sale in person. All bidders must qualify to bid prior to being able to bid on properties.

Real Estate Cont....

- After the courts approve the highest bid, funds are disbursed to the City by the attorney. If there are surplus funds remaining and the property owner owes other monies to the city, I will request for those funds to satisfy the other delinquencies. Any remaining funds, the attorney is required to send those funds to the Clerk of Courts for a period of two years. If no one claims the funds the courts return the balance to the city after the two year period. This year we received \$100,037.00 surplus money from a tax sale we held back in 2021 on three properties.
- We are currently working on having our next tax sale in the Spring of 2024.
- For the RE2022 tax year, of the 6.6 million budgeted, we have \$189,665.38 uncollected, showing a 97.5 collection rate as of November 30, 2023. Any payments paid on delinquent real estate is applied to the oldest taxes first.

Personal Property:

As of November 30, 2023 there is \$347,236.45 in delinquent personal property taxes for tax years 2016-2021. The cumulative collection rate for these years is 97.2 %. I noticed an increase in the personal property delinquencies mainly due to the higher assessments on vehicles for tax year 2022. Even though the city based the taxes on 75% of the assessment it still caused the tax bills to have a higher amount due. The office continues to place DMV-Stops on delinquent taxes. This is a great tool used by Treasurer's offices across the state. Taxpayers cannot renew their tags until they have the Stop removed which requires the taxes to be paid in full. We continue to work with taxpayers on monthly payment plans. Plans are usually made so that their taxes are satisfied prior to the next years assessments and due date. Any and all prior delinquent taxes must be satisfied prior to being able to make a new payment plan.

Personal Property Cont...

- For PP2022 tax year, of the 3.4 million budgeted, we have \$220,393.67 uncollected, showing a 91.4% collection rate as of November 30, 2023. DMV-Stop have been added to the vehicles that we have been able to locate in the system. Debt Set-Off is also added to the account so that when a taxpayer files their state taxes and are due a refund, those refunds are sent to the City.
- Due to the Statue of Limitations as per The Code of Virginia 58.1-3040, I will be requesting City Council to approve charging off personal property taxes for tax year 2016 in the amount of \$26,502.17. Based on years of collection attempts, I deem these accounts uncollectable.
- In working with the Commissioner of the Revenue, we have accounts that the property owner are deceased and the property has been junked and no long on the DMV records as an active vehicle. These accounts will also need to be charged off.

Meals and Lodging:


Currently we have three business that have delinquent meals taxes in the amount of \$28,631.85. Two of the restaurants have closed their doors leaving money owed to the city. I have turned them over to my tax attorney and we have gone to court and obtained a judgement on the owners. I'm working with the other business. If the owner continues with a payment plan no additional collection or legal action will be done.

Business License:


As of November 30, 2023 there are 3 delinquent business licenses in the amount of \$6,260.58. One business has closed and no longer in the area and I have turned them over to the Tax Attorney and he filed a judgement against the owner. We have located one of the businesses and they are going to take care of the delinquent taxes and they are no longer in the Business Center. One of the businesses the owner has closed and has since moved out of state.

Treasurer's Office News:

Collection Percentage Rate for the office:

- Cumulative Percentage for Real Estate for 2003-2021 is 99.86%
- Cumulative Percentage for personal Property for 2016-2021 is 97.27%

The Treasurer's Office was awarded the Office Accreditation for the Tenth year in a row by the Treasurer's Association of Virginia. This is the highest award given by the association. To receive this award the office must have a collection rate of 95% or higher for Real Estate and 90% or higher for Personal Property along with meeting other requirements set by the association. Offices are audited after the office submits their application.

I finished up a year as the 80th President of the Treasurer's Association of Virginia. It was a humbling yet rewarding experience. This was the first time that a City of Franklin Treasurer has ever served in this capacity and I was honored to represent the City Franklin as the TAV President.

This year Deputy Treasurer Edward Martin became certified as a Master Governmental Deputy Treasurer with the UVA Weldon Cooper Center for Public Service. This is a great honor for him to have achieved.

This year I re-certified as a Master Governmental Treasurer for the fourth time. Each certification is for a 4 year term.

The Staff in the Treasurer's Office works hard to service the citizens of Franklin to the best of their ability. The two newest employees have been with the office for a little over a year and are doing extremely well and are taking on new duties. General Updates

• Staff continues to work on the various capital projects approved by City Council.

- o Kimley Horne has been hired to navigate the HUD Grant process as mentioned in the previous City Council meeting. Our preliminary HUD package has been submitted to HUD and has been referred to final review. We are in the final stages of procuring the architect and should be able to start construction documents in the first quarter of 2024.
- O The staff committee for the courthouse renovation project will consist of Chief Steve Patterson, Chad Edwards, and Lin Darden. The judges, Clerk of Court, and Sherriff's Department in addition to other stakeholders will be consulted throughout the design process. A meeting was held with the architects and judges. Final changes to the plans are being made and we are now beginning to work on a more concrete timeline.
- O The staff committee met regarding Riverwalk Park.
 - The kayak design is underway. Survey is complete for the kayak launch additional area. We will incorporate this into the site plans.
 - Kayak launch design underway.
 - Flood study (no-rise study) underway. Not all bridge crossings requested from City are available. Awaiting completion of kayak launch to update.
 - At the moment we're currently awaiting the final site plan and kayak launch design before we can move forward with the Joint Permit Application for the VMRC and Corps permits. Once we have the final design in hand, we can prepare the required impacts mapping and update details relating to the VMRC component of the application. It should take us around 2 weeks to finalize the application after the plans are received.
- Staff continues to work with DHCD and Kimely Horn on the Laurel Street CDBG Grant. Client intake and income verifications have begun and contracts are about to be issued. There may be a funding shortage so the Management Team is investigating other sources of funds potentially including HOME Funds.
- Staff continues to meet with regional partners to discuss next steps on the regional radio system as well as violence and crime prevention.
- Three responses were received for the Franklin Southampton radio project and they are currently under review by the review team. Interviews of those firms are being scheduled for the first week in January.
- Staff continues to work with Court Services and our other locality partners for both short and long term solutions to the juvenile detention situation. An RFP to procure an architect to design a potential expansion of Western Tidewater Regional Jail. Mosley Architects has been selected to assist the Western Tidewater Jail Board to conduct the necessary feasibility study. A kick off meeting with Mosely was held on November 20th.

- The Literary Loan process continues with Franklin City Public Schools. The contactor is working on the project and the first draw of funds is underway. A second application was considered earlier on the agenda.
- City Council held a retreat on March 2nd. The following topics were discussed and will be worked on by staff:
 - o Food Trucks
 - Two food trucks have received final approval.
 - o Increased Code Enforcement
 - Staff is working on a demolition plan for the posted unsafe structures. We are putting a plan in place to prepare for high grass season. We are working with legal to draft updated ordinances for parking and vehicles.
 - o Communication with Franklin City Public Schools
 - We held a joint meeting with Franklin City Public Schools on March 30th. Additional meetings are being scheduled to maintain communication.
 - o Increased focus and investment in Public Safety
 - Additional positions are included in the FY 24 budget. The updated radio system project is moving to Phase 2.
 - Historic District
 - Staff is reviewing the ordinance that is in place and providing a list of the individuals that need to be appointed. Staff is waiting on appointments from Franklin City Council.
 - o Special Tax Districts
 - Under discussion and research ongoing.
 - o Camp Community College Partnerships
 - Under discussion.
 - o Improved Communication with the Public through various means
 - A review of the PEG Channel and necessary equipment purchases are underway. Staff is working to update City Clips. Staff is researching other best practices. An Instagram page has been created.
