Financial Matters:

A. Budget Amendment 2025-01

The Interim City Manager presented Budget Amendment 2025-01. She requested Sarah Rexrode, Director of Social Services to come forward to explain the Fatherhood Incentive Grant. Ms. Rexrode stated this is the first time the Fatherhood Incentive Grant has been offered to the Department of Social Services. She added this grant is for engaging and supporting fathers, or father figures. She continued by saying that when she was trying to find a way to engage fathers she thought about how Parks & Recreation could be a part of this wonderful opportunity. Ms. Green, Director of Parks & Recreation was very gracious and excited to gather ideas on how to work together. Ms. Rexrode reported that the City is offering free pool passes for fathers, or father figures for up to five people for the entire 2024 Summer Season. Ms. Rexrode stated that it is a \$70.00 value and all individuals have to do is sign up. She added that there are 70-75 sign ups available. The Department of Social Services and Parks &

Recreation Department have several other exciting things planned throughout the year which includes a chaperoned field trip. Ms. Rexrode stated that she wants to tailor part of the grant to individuals who may not get to go out of town with their children very often. A destination has not been decided at this time.

Mayor Robert Cutchins stated that the grant sounds very exciting and gives fathers in the area the opportunity to bond with their children without having to worry about the financial impact. Councilman Gregory McLemore asked how the City plans to inform the fathers of the program. Ms. Rexrode stated that staff has started by creating flyers for social media as well as the presentation was to further spread the information publicly. She added that individuals can contact the Department of Social Services or Parks & Recreation for further details. Councilman Gregory McLemore asked if it was a Federal or State Grant. Ms. Rexrode informed Council that the grant is through the Virginia Department of Social Services; therefore, the funding came from Federal and State funds but require no local match. Councilman McLemore asked if any of the grant funds could go toward helping fathers who maybe behind on child support. Ms. Rexrode stated that the grant would not be able to address the issue due to the grant being specifically for engaging fathers.

Ms. Burcham recommended the Council amend the 2023-2024 City Budget as follows:

Old/New Business:

A. Historic Preservation Presentation

Aaron Barnes, Director of Community Development informed Council that he contacted the Department of Historic Resources in May after several discussions with Council and Citizens regarding the need to preserve historic homes in Franklin and what options are available. He added that Joanna McKnight with the Department of Historic Resources hosted a one-on-one meeting at the Franklin Business Center before coming to the City Council Meeting. He added that 12 people showed up to that meeting.

Ms. Joanna McKnight, Architectural Historian based out of Richmond, Virginia stated that her office manages the eastern region of the state. She stated that while being the Historic Preservation Office, they do not only look at buildings, although that is her personal focus the agency focuses on much more. The mission of the agency is to identify historic places, educate the public, connect communities with their histories, and equip Virginias with the tools to foster historic preservation. She added that they maintain their mission through a variety of grants, technical advice and guidance not only for citizens but local governments as well. She added that she is excited to provide further details regarding various programs and funding at a later meeting if Council is interested.

Councilman Linwood Johnson asked if a grant is available to the City for preservation of some of the historic homes in the area. Ms. McKnight stated that the City, staff would need to work through the preservation planning department but not the rehabilitation of private property. She added that the preservation planning department would assistant guidance for owners while working with the City before the homes are too far damaged. She stated that as a Federal and State Historic District, there are no restrictions; therefore, homes can be demolished and changed during restoration. Ms. McKnight stated that she is happy to come before Council at a later date and give a break down on all of the various programs and options available to the City of Franklin.

Mayor Robert Cutchins thanked Ms. Joanna McKnight for her time and stated he is excited to hear more about this topic.

B. FSEDI FY23 Report

Ms. Burcham invited Mr. Karl Heck, President & CEO of the Franklin Southampton Economic Development, Inc. to present the FSEDI FY23 Report. Mr. Heck stated that the Business Center had 161 Full-Time and 41 Part-Time Employees which is an increase of 28 from FY22. The amount of client paid rent to the City of Franklin was \$204,625.24.

Eight (8) new and/or expanding clients signed leases at the Franklin Business Center.

Mr. Heck stated that FSEDI assisted with the development of the hotel/event space project which made significant strides during 2023-2024. Global Concentrate moves closer to ground-breaking as they are in the process on of receiving their final permits. FSEDI is marketing the former Rite Aid building and there has been some interest in the building. Franklin Business Center reached 100% occupancy during portions of the 2023-2024 year. The current occupancy is 87% with 36 tenants currently in the building. The Franklin Southampton Community Visioning process began this year. The process is an update of the 2004 Franklin Southampton Futures that created FSEDI, providing an opportunity to create a new path forward in Franklin and Southampton. The renovation of the former Tidewater News building for the new Camp Community College Nursing and Allied Health facility is progressing well and plans to begin operation in 2024. The STARTUP winner, West Wellness Co. opened in downtown Franklin and the current STARTUP winner Jett Production Company is working on obtaining space in Downtown Franklin. Mr. Heck stated there are several other projects that were very successful in FSEDI.

Mayor Robert Cutchins thanked Mr. Heck for his time and hard work improving the City of Franklin.

C. Sale of Property (Parcel #69-01-042) – Public Hearing

Ms. Burcham indicated that this matter was brought to Council previously and Mr. Karl Heck, President & CEO of the Franklin Southampton Economic Development, Inc. would present the details. Mr. Heck informed Council that Repair Tech is a company which is located in a shared services area of Isle of Wight County and the City of Franklin. Their current company property borders the City of Franklin property. Repair Tech wishes to expand their property. Mr. Heck shared with Council that Mr. Sawyer, Owner of Repair Tech is also attending the meeting.

Mayor Robert Cutchins opened the Public Hearing regarding the Sale of Property (Parcel #69-01-042).

Mayor Robert Cutchins called for public comment three times.

No citizens spoke at this time.

Mayor Robert Cutchins closed the Public Hearing and entertained comments from Council.

Councilman Ray Smith made a motion to conclude the sale of 8.2 acres to Repair Tech with a second from Councilman Mark Kitchen.

Councilman Gregory McLemore asked what the final amount per acre that the City will be paid. Mr. Karl Heck stated \$66,000.00 total.

Mayor Robert Cutchins thanked Mr. Sawyer for all that he and his company has done for the City of Franklin and surrounding areas.

D. Council's Comments

Councilman Linwood Johnson stated that the City of Franklin is moving in the right direction and that staff should keep up the good work.

Councilman Mark Kitchen had no comments at this time.

Councilwomen Jessica Banks stated that Camp Courageous is currently happening within the City, which utilizes the Armory Pool every week. Councilwomen Banks wanted to thank the Parks & Recreation Department again for all of their hard work and dedication to the City of Franklin.

Vice-Mayor Wynndolyn Copeland stated that with regards to the Community Development Block Grant, there are two rehabs on Laurel Street which are substantially complete and there are two rehabs on Laurel Street which are currently under construction. The project team participates receiving bids for four additional rehabs on Oak Street the week of July 29, 2024. The project team is utilizing CDBG funds and hopes to focus to leverage additional funding sources including Project Homes and Lead Hazard Reduction.

Councilman Ray Smith thanked Interim City Manager. He stated that the City of Franklin has been sitting on a lot of projects for a number of years and he appreciates her moving them forward.

Councilman Gregory McLemore had no comments at this time.

Mayor Robert Cutchins had no comments at this time.

E. City Manager's Report

City Manager Burcham stated that several individuals have shown concern about the Barratt's Landing Boardwalk being in disrepair. She informed citizens that a solution has been identified and will cost the City of Franklin \$55,000.00. She added that several HVAC units have died in various buildings. Several complaints regarding the maintenance of City streets have been received. She informed Council that

due to the current vacancies in the Public Works Department, work is having to be prioritized. Ms. Burcham added that unless there is objections from the Council, she intends to fill the three positions which are on hold. She learned much to her surprise, that there are fourteen employees who are making less than \$15.00 hour. She added that in today's world, this is a challenge when recruiting individuals. She stated that unless there is objection from Council, she intends to increase the fourteen individuals to the \$15.00 minimum. Ms. Burcham stated that there was another position in the budget which was available for funding as a Recreation Coordinator that title will be changed to Recreation Supervisor as there needs to be someone in charge when the Director of Parks & Recreation is out. Council had no objections to any of the items listed.

Ms. Burcham stated that an acting Building Official, Doug Smith has been hired. He is a retired Building Official with many years of experience and was recommended to the City of Franklin by the DHCD. Ms. Burcham stated she hopes to introduce him at the next City Council Meeting.

Ms. Burcham informed citizens that there is a new disconnection law which took place July 1, 2024 that no electric, water or wastewater utility can be disconnected for any residential customer for nonpayment or fees when the forecasted temperature is either at or below 32 degrees Fahrenheit or above 92 degrees Fahrenheit in the Summer as determined by the National Weather Service. Several of the items have been the practive of the City of Franklin already, but now it is state law. - Lack of qualified certified and non-certified applicants.
 - Since 2020 applicants to police agencies have dwindled.
 - We average less than 10 police applicants a year.
 - Backgrounds remove several. We are not lowering our standards.
 - In the future we need an incentive to attract new employees and retain existing employees.
- Length of time to train non-certified employees.
 - Police academy is 6 months.
 - Post academy is 4 weeks.
 - Field training is 12 weeks.
 - Total time 11 months.
- Turnover causes large gaps in time where existing employees have to fill in.

RESOLUTION OF THE CITY OF FRANKLIN CITY, VIRGINIA APPROVING A LOAN FROM THE LITERARY FUND OF VIRGINIA FOR SCHOOL ROOF RENOVATION PROJECTS

RESOLUTION #2024-23

WHEREAS, the City Council (the "City Council") of the City of Franklin, Virginia (the "City") has determined that there is an urgent need to make capital improvements to the City's school facilities, specifically roof replacements and similar renovations at various school facilities for school purposes (the "Project"); and

WHEREAS, the Franklin City School Board (the "School Board") and the City previously applied to the Virginia Board of Education through its Department of Education ("VDOE") for the purpose of borrowing in a loan from the Virginia Literary Fund through the Virginia Literary Loan Program (the "Literary Loan") of \$2,000,000 to be paid over not more than 20 years, and the interest rate thereon at not more than 2.00% paid annually and be treated as general obligation bonds of the City for the purpose of financing the Project for school purposes and such Literary Loan has been approved by VDOE; and

WHEREAS, the City Council has held a public hearing on this date on the issuance of the Bond (as defined below) and the approval of the Literary Loan; and

WHEREAS, such Literary Loan are in addition to a similar loan for the Project issued in 2023 consisting of two \$1,000,000 loans, one for roof replacements at Franklin High School and one for S.P. Morton Elementary School;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FRANKLIN, VIRGINIA:

- 1. Authorization of the Bond and Documents. The City Council, after public hearing, hereby finds and determines that it is advisable and in the best interests of the City to enter into a Literary Loan by contracting a debt and issue and sell its general obligation bond or bonds in one or more series, including any temporary notes or bond required by VDOE during the Project construction period, in substantially the form attached hereto as **Exhibit A**, or such other form required by VDOE (the "Bond") for the purpose of financing the Project and costs of issuing the Bond. The City Council hereby authorizes the Literary Loan and in connection therewith, the issuance and sale of the Bond in accordance with the terms established pursuant to this Resolution.
- 2. **Details of the Bond**. The City Council hereby approves (a) the maximum aggregate principal amount of the Bond of \$2,000,000 (expected to consist of a series 2024A bond and a series 2024B each in the aggregate principal amount of \$1,000,000) with a fixed interest rate not to exceed 2.00% and for an amortization of not more than 20 years from the date of the permanent Bond or Bonds, subject to other terms as set forth therein with such changes, including but not limited to, changes in the amounts, dates, amortization, payment dates and redemption premiums

or prepayment penalties and rates as may be approved by the officer executing it whose signature shall be conclusive evidence of his approval of the same.

- 3. Pledge of Full Faith and Credit. The Bond shall be issued under the provisions of Article VII, Section 10(a) of the Constitution of Virginia. The Bond will be secured by the full faith and credit of the City. For the prompt payment of the principal of, premium, if any, and interest on the Bond as the same shall become due, the full faith and credit of the City are hereby irrevocably pledged. Pursuant to Virginia Code Section 15.2-2624 and as provided hereafter, there shall be levied and collected an annual tax upon all taxable property in the City subject to local taxation sufficient to provide for the payment of the principal of, premium, if any, and interest on the Bond as the same shall become due, which tax shall be without limitation as to rate or amount and shall be in addition to all other taxes authorized to be levied in the City to the extent other funds of the City are not lawfully available and appropriated for such purpose.
- 4. Other Actions. All other actions of officers of the City taken heretofore or hereafter conforming with the purposes and intent of this Resolution and in furtherance of entering into the Literary Loan, the issuance and sale of the Bond and the financing of the Project are approved, ratified and confirmed. The officers and representatives of the City are authorized and directed to execute and deliver all documents, agreements, undertakings, certificates and other instruments and to take all such further action as may be considered necessary or desirable in connection with the issuance, sale and delivery of the Bond and the financing of the Project, including without limitation entering into a loan or financing agreement, if necessary, execution of any appropriate documents confirming the City's acceptance of the proposal from VDOE, execution and delivery of IRS Form 8038-G as determined necessary by bond counsel and execution and delivery of any requisitions or other documentation of costs related to the Project and conversion of the Literary Loan from a temporary note to a permanent loan.
- 5. <u>Bond Counsel and Financial Advisor</u>. The City Council hereby confirms the appointment of Sands Anderson PC to serve as Bond Counsel to the City and Davenport & Company, LLC as Financial Advisor to the City in connection with the issuance of the Bond.
- 6. <u>Limitation of Liability of Officials of the City</u>. No covenant, condition, agreement or obligation contained herein shall be deemed to be a covenant, condition, agreement or obligation of any officer, employee or agent of the City in his or her individual capacity, and no officer of the City executing the Bond shall be liable personally on the Bond or be subject to any personal liability or accountability by reason of the issuance thereof.
- Arbitrage Covenants. The City covenants that it shall not take or omit to take any action the taking or omission of which will cause the Bond to be "arbitrage bonds" within the meaning of Section 148 of the Internal Revenue Code of 1986, as amended, and regulations issued pursuant thereto (the "Code"), or otherwise cause interest on the Bond to be includable in the gross income for Federal income tax purposes of the registered owner thereof under existing law. Without limiting the generality of the foregoing, the City shall comply with any provision of the Tax Compliance Agreement (as defined below) that may require the City at any time to rebate to the United States any part of the earnings derived from the investment of the gross proceeds of the Bond, unless the City receives an opinion of nationally recognized bond counsel that such

compliance is not required to prevent interest on the Bond from being included in the gross income for federal income tax purposes of the registered owners thereof under existing law. The City shall pay any such required rebate from legally available funds.

- 8. <u>Tax Compliance Agreement</u>. Such officers of the City as may be requested by the City's bond counsel are authorized and directed to execute and deliver a nonarbitrage certificate and tax compliance agreement in relation to the Bond (the "Tax Compliance Agreement") in the form approved by the Mayor or Vice Mayor of the City or the City Manager, or any of them, in collaboration with the City's bond counsel, with such completions, omissions, insertions and changes as may be approved by the officers of the City executing such Tax Compliance Agreement, whose approval shall be evidenced conclusively by the execution and delivery thereof.
- 9. **Private Activity Bond Covenant**. The City covenants that it shall not permit the proceeds of the Bond or the property financed thereby to be used in any manner that would result in (a) 5% or more of such proceeds or the facilities financed with such proceeds being used in a trade or business carried on by any person other than a governmental unit, as provided in Section 141(b) of the Code, (b) 5% or more of such proceeds or the facilities financed with such proceeds being used with respect to any output facility (other than a facility for the furnishing of water), within the meaning of Section 141(b)(4) of the Code, or (c) 5% or more of such proceeds being used directly or indirectly to make or finance loans to any persons other than a governmental unit, as provided in Section 141(c) of the Code; provided, however, that if the City receives an opinion of nationally recognized bond counsel that any such covenants need not be complied with to prevent the interest on the Bond from being includable in the gross income for federal income tax purposes of the registered owners thereof under existing law, the City need not comply with such covenants.
- 10. <u>Filing of Resolution</u>. The Clerk or any Deputy Clerk of the City Council or other agent or employee of the City, is hereby authorized and directed to cause a certified copy of this Resolution to be filed with the Circuit Court of the County of Southampton, Virginia.
- 11. **Repeal of Conflicting Actions**. All resolutions or parts thereof in conflict herewith are repealed.
- 12. <u>Effective Date.</u> This Resolution and the provisions contained herein shall become effective immediately upon adoption.







ARTICLE IX. B-2 Central Business District Use Regulations

NOW, THEREFORE, BE IT ORDAINED AND RESOLVED by the Council for the City of Franklin, Virginia that the Zoning District Map provided for in Section 1.2 of the City Zoning Ordinance is hereby amended to establish the following zoning classification for the parcel comprising of approximately 0.13 acres of property known as a portion of the City of Franklin Tax Parcel No. 107-55-10-25 from Light Industrial (M-1) to Central Business (B-2).

Baker's Home, Inc.

For more than 40 years, Baker's Home, a minority family-owned business, has been serving the Franklin and Western Tidewater community. Its founder, Estelle Baker, established Baker's Home for Adults, Inc. to meet the growing need for housing and overall care for older and disenfranchised members of the community. The service to the community began as a home for adults, then as an assisted living facility. Over time, the community evolved, and the needs changed. There became a great need for mental health services and in 2000, Baker's Home, Inc. began providing behavioral health services to meet that need. Since then, the community need has again shifted and now there is a substance abuse crisis. Keeping in line with the founding principle of meeting the needs of the community, Baker's Home is attempting to do its part in combating the area's substance abuse problem and the issues that are sometimes found when substance abuse is present.

To accomplish this, Baker's Home wants to operate as a Residential Crisis Stabilization Unit for adults in our current headquarters located at 204 Morton Street in Franklin, VA. Residential Crisis Stabilization Units (RCSUs) provide short-term, 24/7, residential psychiatric and substance related assessment and brief intervention services. The service supports the following individuals: individuals experiencing changes in behavior noted by impairment or decompensation in functioning that may result in the need of a higher level of care; individuals stepping down from a higher level of care that need continued monitoring, stabilization and mobilization of resources; and individuals who need a safe environment for assessment, stabilization, and prevention of further escalation or decompensation. RCSUs may also provide medically monitored residential services for the purpose of providing psychiatric stabilization and substance withdrawal management services on a short-term basis. The goals of RCSU services are as follows but are not limited to: 1) stabilize the individual in a community-based setting and support the individual and natural support system; 2) reduction of acute symptoms; and 3) identification and mobilization of available resources including support networks. This service occurs in a non-hospital, community-based crisis stabilization residential unit with no more than 16 beds. The critical features or the covered service components of RCSUs include assessment (medical, psychiatric evaluation, nursing assessment, etc.); care coordination; crisis intervention; health literacy counseling; individual, group and/or family therapy; peer recovery support services; skills restoration; and treatment planning.

RCSU will provide:

- 24-hour nursing staff
- Licensed Mental Health Professionals (LMHP) for program oversite
- Certified Substance Abuse Counselors (CSAC)
- Qualified Mental Health Counselors (QMHP)
- Peer Recovery Specialists
- Food Services- 3 meals a day
- Laundry Services

Critical Features/Covered Service Components of RCSUs include:

- Assessment (medical, psychiatric evaluation, nursing assessment, etc.)
- Care Coordination
- Crisis Intervention
- Health Literacy Counseling
- Individual, Group and/or Family Therapy


- Peer Recovery Support Services
- Skills Restoration
- Treatment Planning

Appendix D. Zoning Ordinance

ARTICLE XXVIII. Changes and Amendments

§ 28.9. Special use permits for uses not provided for.

[Amended by Ord. 9-25-2023]

- (1) If, in any district established under this ordinance, a use is not specifically permitted and an application is made to the zoning administrator for such use, the zoning administrator shall refer the application to the planning commission as a special use permit. The planning commission shall make its recommendation to the city council after holding a public hearing on the said application.
 - The city council may, after receiving the recommendations from the planning commission and after holding a public hearing on said application, issue a special use permit for said use for a temporary period or permanently, as determined by the council, upon such conditions as the council may deem necessary to safeguard and protect the public health, morals, safety and general welfare of the neighborhood or area within the proposed use will be located.
- (2) Initiation of special use permit.
 - (a) The property owner or other person with an enforceable legal interest in the property may file an application for a special use permit.
- (3) Application for special use. An application for special use shall be filed with the zoning administrator on a form prescribed by the zoning administrator. The application shall be accompanied by such plans and/or data as necessary, and shall include a statement in writing by the applicant and adequate evidence showing that the proposed use will conform to the standards set forth. Such application shall be forwarded from the zoning administrator to the planning commission for review and recommendation. The planning commission shall conduct a public hearing and render a recommendation on the application, which shall be forwarded to city council.
- (4) Planning commission recommendation. The planning commission, after public notice and hearing, shall forward its recommendation to city council which in turn shall hold another hearing.
- (5) The city council after public notice and hearing and upon recommendation by the planning commission may authorize the issuance of special use permits in harmony with the general purpose and intent, as hereinafter provided, and subject to appropriate conditions.
- (6) Standards for review of a special use application. The planning commission and city council shall consider the following criteria before the granting of a special use permit:
 - (a) That the establishment, maintenance, and operation of the special use will not be detrimental
 to or endanger the public health, safety, and general welfare;
 - (b) That the special use will not be injurious to the use and enjoyment of other property in the immediate vicinity for the purposes already permitted, nor substantially impair the use of other property within the immediate proximity;
 - (c) That adequate utilities, water, sewer or septic system, access roads, storm drainage and/or other necessary public facilities and improvements have been or will be provided;

- (d) That adequate measures have been or will be taken to provide ingress and egress so designed as to minimize traffic congestion on the public streets;
- (e) That the proposed special use is not contrary to the goals and objectives of the Isle of Wight County Comprehensive Plan;
- (f) That the special use shall, in all other respects, conform to the applicable regulations of the zoning district classification in which it is located and to the special requirements established for the specific use;
- (g) That the use(s) at the location proposed will not result in a multiplicity or saturation of similar uses in the same general neighborhood of the proposed use.
- (7) Conditions and guarantees. The city council may impose conditions or limitations on any approval, including the posting of performance guarantees. Such conditions may include, but are not necessarily limited to:
 - (a) The number of persons living or working in the immediate area and the proposed hours of operation, as may be applicable;
 - (b) Traffic conditions, including facilities for pedestrians, such as sidewalks and parking facilities; the access of vehicles to roads; peak periods of traffic; and proposed roads, but only if construction of such roads will commence within the reasonably foreseeable future;
 - (c) The orderly growth of the neighborhood and community and the fiscal impact on the city;
 - (d) The effect of odors, dust, gas, smoke, furnes, vibration, glare, and noise upon the use of surrounding properties;
 - (e) Facilities for police, fire protection, sewerage, water, trash and garbage collection and disposal, and the ability of the county or persons to supply such services;
 - (f) The degree to which the development is consistent with generally accepted engineering and planning principles and practices;
 - (g) The structures in the vicinity such as schools, houses of worship, theaters, hospitals, and similar places of public use;
 - (h) The purposes set forth in this ordinance, the county's comprehensive plan, and related studies for land use, roads, parks, schools, sewers, water, population, recreation, and the like;
 - (i) The environmental impact, the effect on sensitive natural features, and opportunities for recreation and open space;
 - (i) The preservation of cultural and historic resources or landmarks.
- (8) Other laws applicable. The granting of a special use does not exempt the applicant from obtaining a zoning permit certificate or complying with all other requirements of this ordinance or any applicable county, state, or federal law.
- (9) Denial of a special use permit. If the city council finds that in an application for a special use provided in this ordinance and requested in said application will not conform to the general character of the neighborhood to which the proposed use will apply, and that the public health, safety and general welfare of such neighborhood will not be secure by granting such special use, then the city council may deny such application, anything in this ordinance to the contrary notwithstanding.
- (10) Effect of denial of a special use.
 - (a) No application for a special use which has been denied wholly or in part by city council shall be resubmitted for a period of one (1) year from the date of said order of denial, except on the grounds of new evidence or proof of change of conditions found to be valid by council.

Ordinance 2024-09

AN ORDINANCE TO AMEND THE CITY OF FRANKLIN CODE CHAPTER 31: WEAPONS, SECTION 31-4: DISCHARGING FIREARMS

THE COUNCIL OF THE CITY OF FRANKLIN, VIRGINIA ORDAINS AS FOLLOWS:

That Chapter 31: Weapons, Section 31-4: Discharging Firearms is hereby amended as followed:

§ 31-4. Discharging Firearms

- (a) No person shall discharge any firearms within the City; provided that this prohibition shall not apply to (1) a law enforcement officer in the discharge of official duties; (2) a person whose actions are justifiable or excusable in law in the protection of life or property; (3) a person discharging a weapon at a licensed shooting range or shooting gallery; (4) a person firing blanks at a theatrical or sporting event; (5) (A) a person legally hunting in the City, in that portion of the City south of Armory Drive and Second Avenue on no more of two of three days chosen from the third Tuesday in December and the following Wednesday and Thursday between the hours of 8:30 a.m. and 1:00 p.m.; or (C) a person still hunting deer during deer hunting season in that portion of the City south of Armory Drive and Second Avenue with access being limited to private gate accessed road off South Street or to Amber Street and with the limitation that landowners may grant permits (which must be in writing) to no more than six persons per day to still hunt on their property in that area of the City, any such hunting under (5)(A), (B) or (C) above being with the permission of the land owner using a shotgun, a pistol or a rifle no more than .22 caliber at least a distance of 150 yards from any building, river, roadway, or from the property line of a school or park.
- (b) The City Manager have a notice of the dates for deer hunting under Subsection (a)(5)(B) above published annually in a newspaper having general circulation in the City two times in the week prior to the week in which deer hunting may occur thereunder and shall mail or deliver a copy of such notice to the Chief of Police and the local game warden.
- (c) Still hunting as used in this section shall mean hunting without the use of dogs

FIRST AMENDMENT SOUTHAMPTON COUNTY AND CITY OF FRANKLIN P25 RADIO PROJECT INFRASTRUCTURE MEMORANDUM OF UNDERSTANDING

This First Amendment to the Memorandum of Understanding ("MOU") regarding the P25 Radio Project Infrastructure is made this 12th day of August, 2024, by and between the County of Southampton, Virginia, a political subdivision of the Commonwealth of Virginia ("Southampton") and the City of Franklin, Virginia, a municipal corporation of the Commonwealth of Virginia ("Franklin") (also individually referred to herein as "Party" and collectively as the "Parties").

WHEREAS, the governing bodies of Southampton and Franklin determined that it was in the best interest of each jurisdiction to support the mission-critical needs of the Parties' individual and collective public safety and public service personnel, and citizens' property and business interests by maintaining, at the highest level of availability and integrity, the JVCKenwood P25 Phase 2 trunked simulcast radio system; and

WHEREAS, the Parties entered into the MOU on May 1, 2024 ("MOU"); and

WHEREAS, Article II. <u>RADIO SYSTEM GOVERNANCE</u>, Section 2-6, of the MOU states that

[t]he Parties shall individually and collaboratively seek grants to enhance the public safety communication network. Any grants must be approved by the Parties. Matching requirements for grants will be paid by all Parties according to the Party allocation percentage outlined in Section 3-1, below. Any grant funds received by the Parties will be applied to the P25 Radio System costs so as to lower the overall total cost of the System to the greatest extent possible. If a Party receives a grant to enhance the public safety communications network and the receipt of such grant is solely attributable to the efforts of the Party, such grant funds will be applied only to such Party's payment obligations. The Parties agree to share information on available

grants and to cooperate on grant applications to the greatest extent possible for the benefit of the System

; and

WHEREAS, the Parties wish to amend the MOU pursuant to Article VII.

MISCELLANEOUS, Sec. 7-3 thereof.

NOW, THEREFORE, in consideration of the promises and the mutual covenants and agreements set forth herein, the Parties agree as follows:

1. Article II. <u>RADIO SYSTEM GOVERNANCE</u>, Sec. 2-6, of the MOU is amended and replaced in its entirety to read as follows:

The Parties shall individually and collaboratively seek grants to enhance the public safety communication network. Any grants must be approved by the Parties. Matching requirements for grants will be paid by all Parties according to the Party allocation percentage outlined in Section 3-1, below. Any grant funds received by the Parties will be applied to the P25 Radio System costs so as to lower the overall total cost of the System to the greatest extent possible. Notwithstanding the allocation percentage outline in Section 3-1 below, any grant funds received to enhance the public safety communications network shall be applied in a 50/50 split to the Parties' payment obligations, regardless of which party expended the effort to secure the grant. The Parties agree to share information on available grants and to cooperate on grant applications to the greatest extent possible for the benefit of the System.

2. Except as amended herein, the MOU will remain in full force and effect.

IN WITNESS WHEREOF, the Parties have caused this First Amendment to the Memorandum of Understanding ("MOU") regarding the P25 Radio Project Infrastructure entered into by Southampton County and City of Franklin to be executed in their respective corporate names as of the date first above written.

PICK UP WILL OCCUR ON YOUR REGULAR TRASH DAY ONLY. NO DEMOLITION DEBRIS, TREES OVER 6" IN DIAMETER, LOT-CLEARING MATERIALS, PAINT OR OTHER HAZARDOUS MATERIALS WILL BE COLLECTED. LIMBS MUST BE CUT TO ORDINANCE LENGTH OF 4' LONG AND PILED NEATLY AT CURBSIDE.

ANY ITEMS PLACED AT CURBSIDE SHOULD BE LEFT IN NEAT PILES ADJACENT TO THE STREET. PLEASE BE MINDFUL OF OBSTRUCTIONS WHEN PLACING THOSE ITEMS TO ALLOW FOR SAFE COLLECTION BY OUR CREWS.
