Re: FSEDI Update

I have a brief update of items that FSEDI is working on in the City of Franklin.

- 1) The Franklin Business Center occupancy is at 78%. We are marketing the former Sylvamo space (1600 SF) as a separate space for an "anchor tenant" at market rates. The Business Center Board met on Thursday, though no new tenants were approved. We are working on adding a fingerprinting service, weather camera and improving the Wi-Fi so our clients can be properly served.
- 2) FSEDI continues to work with the engineering team to get the Global Concentrate plans to a place where they can be approved by the City. We remain hopeful for a possible summer groundbreaking, though a considerable amount of work remains to reach that goal. Getting Global's project underway and moving dirt in Franklin is our highest priority.
- 3) Our office continues to work with the real estate agent and owner on possibilities for the former Rite Aid building. While the national chain retail expansion space is generally slow at the present time, we work on any potential expansion candidates that could potentially fit the space.
- 4) We continue to work on hotel recruitment and development possibilities. Blake Blythe's proposal for a mixed-use development around the Walgreen's site has been moving very slowly. We have other possibilities to reactivate regarding potential incentives and sites in the City that potentially could accommodate a midscale/upper midscale hotel.
- 5) Our office is performing a variety of tourism marketing initiatives. We look forward to a closer relationship with the City to promote our area and develop lodging to meet future tourism needs.
- 6) The Franklin Southampton Community Visioning process, administered by FSEDI, had a public meeting on February 4. We are currently developing a forward-facing outreach piece and working on potential projects for our "pitch deck." Pitch deck projects will be marketed to a variety of investors and funders to facilitate implementation.
- 7) The STARTUP Awards and Expo will be held on Wednesday, April 16 at the Hubs Vine from 5:30 to 7 p.m. We invite Council and members of the public to attend.
- 8) Our 2025 National Small Business Week event will be held on Friday, May 2 from 7:30 to 8:45 a.m. at the Franklin Business Center. Bryan Stephens of the Hampton Roads Chamber will once again be our keynote speaker.

- 9) The STARTUP Franklin Southampton Awards and Expo will be held on Wednesday, April 16 from 5:30 to 7:30 p.m. at the Hubs Vine. Three award winners will be crowned. There will be exhibits from current and previous participants in the STARTUP program. STARTUP is having its seventh competition in 2025.
- 10) The Franklin Business Center hosted the January FSA Chamber Brewing Up Business event. The event attracted approximately 25 people to the Business Center.
- 11) FSEDI is part of the Western Tidewater Mechatronics Project. The group received GO Virginia funding to support a curriculum at Camp Community College that will allow more people in our communities to be trained in the mechatronics and logistics industry.
- 12) Home sales remain strong in Franklin. Currently there are 32 homes sold in the Summit. Riverwood only has a couple remaining homes to sell.
- 13) Marmiro Stones, a landscaping and natural stone company headquartered in New Jersey, has purchased and moved into the former Tinder Transfer warehouse on Sachs Avenue. They anticipate having eight employees when they are fully operational. The former electrical supply warehouse in Commerce Park Drive is for sale. We are actively marketing that property.
- 14) FSEDI also markets active retail, commercial and industrial sites in the City.
