- 1) TWO COPIES OF SITE PLAN SHOWING SIGN LOCATION.
2) TWO COPIES OF SIGN DETAILS SHOWING MEASUREMENTS AND MOUNTING DETAILS, STRUCTURAL FOOTING DESIGNS AND ELECTRICAL SPECIFICATIONS.
3) ONLY ONE APPLICATION PER SIGN

NOTE: FREESTANDING SIGNS > 12 FT. HIGH SHALL ALSO HAVE TWO COPIES OF A VIRGINIA REGISTERED STRUCTURAL ENGINEER'S DESIGNED FOOTING DETAIL FOR 90 MPH WIND SPEED EXPOSURE C (per the Virginia Construction Code).
