CONSENT AGENDA:

Selection of Board Officers: Davida Fenner made a motion to keep the same slate of officers for 2018. Pat Newman, Chair; Davida Fenner, Vice-Chair; Gwen Blue, Secretary. Pat Newman seconded the motion. Motion passed with Davida Fenner and Pat Newman voting in favor of the motion.

Candidate Complaint: On March 9, 2018, the Electoral Board received a letter of complaint from Julia N. Boyd, 313 Roosevelt Street, Franklin, VA. Chair Pat Newman read the complaint for the record. A copy of the letter will be included as a part of the minutes of this meeting.

Chair Pat Newman read for the record from *Virginia Election Laws, 2017 Edition, Election Offenses Generally; Penalties. 24.2-1019. Complaints and allegations concerning election law offenses.* Any complaints or allegations concerning unlawful conduct under this title shall be filed with the attorney for the Commonwealth of the county or city in which the alleged violation occurred. In the case of a complaint or allegation concerning the filing of a false statement in a voter registration application, the violation shall be deemed to have occurred in the county or city where the applicant sought to be registered. Davida Fenner made a motion to forward the complaint letter to the Commonwealth Attorney as required by this statute. Pat Newman seconded the


Attendance: Pat Newman, Chair; Davida Fenner, Vice-Chair; Jen Maynard, Registrar.
