NOTE: THIS DOCUMENT CONTAINS IMPORTANT INFORMATION CONCERNING THE VIRGINIA CONTRACTOR'S LICENSING LAW. PLEASE READ CAREFULLY BEFORE SIGNING.

I, _____ of (address) _____ swear and affirm that I am the owner of a certain tract or parcel of land located _____ and further identified as Tax Map # _____ and that I have applied for a Building Permit to erect a structure on said property or repair or improve an existing structure on said land or to perform work which is normally regulated under the Virginia Construction Code. I swear and affirm that all work will be on farm property and consist of farm buildings as defined by the Virginia Construction Code and said structures are exempt from the Purpose and Scope of the Virginia Construction Code under section 102.3, Exemptions. I further swear and affirm that I am aware of the provisions of Title 54, Chapter II, Code of Virginia that require a contractor to be properly licensed before he or she may bid or undertake a job of \$1,001.00 or more. I moreover swear and affirm that I am familiar with the responsibilities of an awarding authority specified in the Code which prohibits any awarding of contracts to any contractor not properly licensed under the provisions of the Code and that to do so would constitute the commission of a misdemeanor. I additionally swear and affirm that I understand that a contractor must be licensed as a Class C Contractor for any job of \$1,001.00 but less than \$10,000.00, a Class B Contractor for any job of \$1,001.00 but less than \$150,000.00 and a contractor must be licensed as a Class A Contractor for any job of \$150,000.00 or more. I likewise swear and affirm that I understand that I am required to comply with the City of Franklin and/or the Southampton County Zoning Ordinance as it pertains to the placement of all such structures.

Please read the following definition and circle the number(s) appropriate to the use(s) of the farm building or structure.

Farm building or structure. A building or structure not used for residential purposes, located on property where farming operations take place, and used primarily for any of the following uses or combination thereof:

1. Storage, handling, production, display, sampling or sale of agricultural, horticultural, floricultural or silvicultural products produced in the farm.
2. Sheltering, raising, handling, processing or sale of agricultural animals or agricultural animal products.
3. Business or office uses relating to the farm operations.
4. Use of farm machinery or equipment or maintenance or storage of vehicles, machinery or equipment on the farm.
5. Storage or use of supplies and materials used on the farm.
6. Implementation of best management practices associated with farm operation
