Code which pro	ohibits any awarding of contracts t	to any contractor not properly licensed unde	r the provisions of
the Code and th	at to do so would constitute the co	commission of a misdemeanor. I additionall	y swear and affirm
that I understan	d that a contractor must be license	ed as a Class C Contractor for any job of \$1,	,001.00 but less
than \$10,000.00), a Class B Contractor for any job	b of \$1,001.00 but less than \$150,000.00 and	d a contractor must
be licensed as a	Class A Contractor for any job or	of \$150,000.00 or more. I likewise swear and	d affirm that I
understand that	I am required to comply with the	e City of Franklin and/or the Southampton Co	ounty Zoning
Ordinance as it	pertains to the placement of all su	uch structures.	

Please read the following definition and circle the number(s) appropriate to the use(s) of the farm building or structure.

Farm building or structure. A building or structure not used for residential purposes, located on property where farming operations take place, and used primarily for any of the following uses or combination thereof:

- 1. Storage, handling, production, display, sampling or sale of agricultural, horticultural, floricultural or silvicultural products produced in the farm.
- 2. Sheltering, raising, handling, processing or sale of agricultural animals or agricultural animal products.
- 3. Business or office uses relating to the farm operations.
- 4. Use of farm machinery or equipment or maintenance or storage of vehicles, machinery or equipment on the farm.
- 5. Storage or use of supplies and materials used on the farm.
- 6. Implementation of best management practices associated with farm operation
